

**SPRING GARDEN TOWNSHIP BOARD OF COMMISSIONERS**

**RESOLUTION NO. 2024-6**

**WHEREAS**, Manchester Township, Springettsbury Township, and Spring Garden Township of York County, Pennsylvania (the "Charter Municipalities") are the Charter Municipalities for the York Area United Fire and Rescue ("YAUFR") under a Charter Agreement adopted pursuant to the Intergovernmental Cooperation Act of the Commonwealth of Pennsylvania; and

**WHEREAS**, YAUFR provides municipal fire services to the Charter Municipalities; and

**WHEREAS**, YAUFR has determined that it is in the best interests of the Charter Municipalities to add three firefighters, one firefighter for each shift, to keep pace with commercial and residential growth occurring in the Charter Municipalities served and protected by YAUFR; and

**WHEREAS**, YAUFR has applied for a grant under the Staffing for Adequate Fire and Emergency Response (SAFER) program to facilitate the staffing increase; and

**WHEREAS**, Spring Garden Township desires to support the grant application.

**NOW THEREFORE BE IT RESOLVED**, that the Board of Commissioners of Spring Garden Township, York County, Pennsylvania, hereby supports the application of the York Area United Fire and Rescue for a grant under the Staffing for Adequate Fire and Emergency Response program to add three firefighters to the YAUFR staff.

**BE IT FURTHER RESOLVED**, that Spring Garden Township hereby calls upon the Federal Emergency Management Agency of the U.S. Department of Homeland Security to issue the grant under the SAFER program, in accordance with the application submitted by YAUFR.


