AN ORDINANCE AMENDING THE GENERAL ORDINANCES OF THE TOWNSHIP OF SPARTA IN ORDER TO ADJUST CERTAIN FEES AND ESCROWS

WHEREAS, the Sparta Township Council has considered the recommendations from the department heads in regard to adjusting the fees and escrows imposed by the Township and desires to make the amendments provided for in this Ordinance.

NOW, THEREFORE, BE IT ORDAINED by the Sparta Township Council, County of Sussex, State of New Jersey as follows:

Section 1. Fees for Police Services.

§2-18.10.a is repealed and replaced with the following:

Whenever the Chief of Police authorizes the assignment of a Township Police Officer or Special Officer to quasi-public duty, the fee for this service shall be equal to the Senior Patrol Officer's overtime hourly rate of prior years' pay or a capped rate, determined by the Chief or his designee, until a fee increase is warranted. Officers will receive a minimum of four (4) hours for each assigned detail. There is a ten (10%) percent Administrative Fee for all hours worked. A fee will be charged, should a patrol vehicle be required for any such quasi-public duty, not to exceed fifty (\$50.00) dollars for any detail lasting up to four (4) hours and, not to exceed, one (\$100.00) hundred dollars for any detail lasting more than four (4) hours.

(b) Change of use of occupancy fee: \$250.00 (Includes four technical applications/processing)

Subsection §12-1.3.14(c) is amended as follows:

(c) Certificate of continued occupancy fee: \$250.00 (Includes four technical applications/processing)

i. Mechanical Subcode

Oil or gas-fired stove or fireplace, water heater, boiler, furnace, air conditioning unit, pool heater and similar devices, oil and propane tanks, oil or gas lines and chimney liners in existing R-3, R-4 and R-5 structures:

- **Section 9. Severability.** If any provision of this ordinance or the application of this ordinance to any person or circumstances is held invalid, the remainder of this ordinance shall not be affected and shall remain in full force and effect.
- **Section 10. Repealer.** All ordinances or parts of ordinances or resolutions inconsistent or in opposition to the provisions of this Ordinance are hereby repealed in their entirety.
- **Section 11. Effective Date.** This ordinance shall take effect after publication and passage according to law.
