ORDINANCE NO.210.205

AN ORDINANCE AMENDING SECTION 210.205(B) OF THE SPARTA CITY ORDINANCES

BE IT ORDAINED BY THE BOARD OF ALDERMAN OF THE CITY OF SPARTA, MISSOURI, AS FOLLOWS:

WHEREAS, the City of Sparta has in place Ordinance Number 210.050 (B) defining the days allowed to discharge fireworks before and after July 4th in the City Limits for the City of Sparta; and

WHEREAS, the City has determined a necessity to amend the days allowed to discharge fireworks before and after July in the City Limits.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMAN OF THE CITY OF SPARTA, CHRISTIAN COUNTY, MISSOURI, AS FOLLOWS:

SECTION B. Section 210.205 is hereby amended to read as follows:

Chapter 210. Offenses

Section 210.205 (B).

Other fireworks may only be discharged within the City Limits three (3) days prior to July 4 and three (3) after July 4 of each year between the hours of 8:00 A.M. and 10:00 P.M. except that on July 4 only, said fireworks may be discharged between the hours of 8:00 A.M. and 11:00 P.M. (Ord. No. 469, 6-8-2010 [seven (7) days prior to July 4 and seven (7) days after]

SECTION 1. All ordinances or parts of ordinances in conflict with this ordinance are hereby repealed insofar as they do conflict.

SECTION 3. This ordinance being necessary for the preservation of the public peace, health, and safety of the citizens of the City of Sparta, Missouri, and this ordinance shall be in force and take effect from and after the date of its passage and approval.
