



ORDINANCE # 1154

AN ORDINANCE OF THE BOROUGH COUNCIL OF THE BOROUGH OF STROUDSBURG IN THE COUNTY OF MONROE, COMMONWEALTH OF PENNSYLVANIA TO AMEND CHAPTER 15 “MOTOR VEHICLES AND TRAFFIC”, SECTION §15-307 1. A. “ALTERNATE PARKING ESTABLISHED ON CERTAIN STREETS”, OF THE STROUDSBURG BOROUGH CODE

WHEREAS, the Stroudsburg Borough Parking Committee met on June 27, 2023 to discuss matters involving the Parking Enforcement Department; and

WHEREAS, the Stroudsburg Borough Parking Committee determined that the following amendment to the Motor Vehicles and Traffic Ordinance of the Stroudsburg Borough Code will increase available parking spaces and not adversely affect the parking needs in these areas;

NOW, THEREFORE, BE IT ORDAINED by the Borough Council of the Borough of Stroudsburg in the County of Monroe, Commonwealth of Pennsylvania that the following sections of the Stroudsburg Borough Code of Ordinances shall be amended accordingly.

§ 15-307 Alternate Parking Established on Certain Streets.

1.

On the following streets, the restrictions on parking stated in § 15-306 will be in effect except for one day per week, which shall be posted as an alternate parking day.

A.

The following streets shall be posted: "Parking this Side Except 5:00 p.m., Wednesday to 5:00 p.m., Thursday" on the side normally used for parking; and posted: "Parking this Side Wednesday 5:00 p.m. to Thursday 5:00 p.m. Only" on the side where parking is normally prohibited.

The following streets shall be posted: "Parking this Side Except 5:00 p.m., Thursday to 5:00 p.m., Friday" on the side normally used for parking; and posted: "Parking this Side Thursday 5:00 p.m. to Friday 5:00 p.m. Only" on the side where parking is normally prohibited.






