AN ORDINANCE OF THE TOWNSHIP OF STAFFORD, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE NAMING OF A STREET NAME IN ACCORDANCE WITH <u>N.J.S.A.</u> 40:67-1(k)

WHEREAS, <u>N.J.S.A.</u> 40:67-1(k) provides for the naming and/or changing of street names within a municipality; and

WHEREAS, Mayor Myhre has requested to name the proposed roadway designated in the Planning Board application P22-08 for Block 124, Lots 38 and 39 as Prosperity Lane to Goldfinch Lane, and this request has been reviewed by the Township Engineer who has determined that the name request complies with the requirements of the ordinances of the Township of Stafford; and

WHEREAS, it is the desire of the governing body to name the proposed roadway designated in the in the Planning Board application P22-08 for Block 124, Lots 38 and 39 as Prosperity Lane to Goldfinch Lane in accordance with N.J.S.A. 40:67-1(k).

NOW, THEREFORE, BE IT ORDAINED, by the governing body of the Township of Stafford, County of Ocean, State of New Jersey, as follows:

SECTION 1. That the governing body does hereby name the proposed roadway designated in the Planning Board application P22-08 for Block 124, Lots 38 and 39 as Prosperity Lane to Goldfinch Lane in accordance with <u>N.J.S.A.</u> 40:67-1(k).

SECTION 2. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 3. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

SECTION 4. This ordinance shall take effect after second reading and

publication as required by law.
