ORDINANCE NO. 2023 -38

AN ORDINANCE OF THE TOWNSHIP OF STAFFORD, COUNTY OF OCEAN, STATE OF NEW JERSEY, PROVIDING FOR THE VACTION OF A PORTION OF CERTAIN RIGHT-OF-WAY KNOWN AS WASHINGTON AVENUE FORMERLY WEST ROAD, LOCATED WITHIN STAFFORD TOWNSHIP, OCEAN COUNTY, NEW JERSEY.

WHEREAS, the Township Council of the Township of Stafford, County of Ocean, State of New Jersey, (hereinafter referred to as the "Township") is of the opinion that certain public interest would best served by abandoning, vacating, releasing and extinguishing any and all public rights which the Township may have in and to a right-of-way and/or paper street location with a portion of Stafford Township, Ocean County, New Jersey, known on the Tax Map as a portion of Washington Avenue formerly West Road of the Township. A complete legal description of the property is attached hereto and labeled as Exhibit "A"; and

WHEREAS, N.J.S.A. 40:67-19 authorizes a municipality by ordinance to release and extinguish the public's rights arising from a dedication of a roadway; and

WHEREAS, the Township Council of the Township of Stafford, County of Ocean, State of New Jersey, is of the opinion that the public interest would be best served by abandoning, vacating, releasing and extinguishing any and all public rights which the Township may have in and to a rights-of-way and/or paper street known as part of Washington Avenue formerly West Road of the Township as shown on Exhibit "A"; and

WHEREAS, Colliers Engineering and Design for the Township have prepared the attached metes and bound description of the area to be vacated dated October 23, 2023, which includes "Right of Way Exhibit" map, dated September 27, 2023.

WHEREAS, pursuant to N.J.S.A. 40:67-1(b), the Township Council must, by Ordinance, preserve the right of public utilities to maintain, repair and replace their existing utility facilities, including cable television facilities, in, adjacent to, over, or under the property or right-of-way to be vacated; and

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Township Council of the Township of Stafford, County of Ocean, State of New Jersey, as follows:

SECTION 1. The public rights and interests are hereby vacated with respect to the portion of the right-of-way and paper street as described in the metes and bounds description prepared by Colliers Engineering & Design (Exhibit A), dated September 27, 2023, copies of which are attached hereto and made a part hereof.

SECTION 2. Be it further ordained that all the rights of any and public utilities and/or cable television companies are hereby expressly reserved and excepted from this vacation.

SECTION 3. The vacated area described herein will be conveyed and consolidated with the adjoining parcels. This Vacation Ordinance shall be duly filed with the Ocean County Clerk's office in Toms River, New Jersey thereby remitting to each of the adjoining properties one-half of the area to be vacation.

SECTION 4. The Mayor and Township Administrator are hereby authorized to take such actions as are necessary to effectuate the purposes of this ordinance.

SECTION 5. Severability. The various parts, sections and clauses of this Ordinance are hereby declared to be severable. If any part, sentence, paragraph, section or clause is adjudged unconstitutional or invalid by a court of competent jurisdiction, the remainder of the Ordinance shall not be affected thereby.

SECTION 6. Repealer. Any ordinances or parts thereof in conflict with the provisions of this Ordinance are hereby repealed to the extent of such conflict.

SECTION 7. Effective Date. This Ordinance shall take effect upon publication in the official newspaper of the Township, as required by and in conformance with law.



All that certain lot, tract or parcel of land situate, lying and being in the Township of Stafford, in the County of Ocean and the State of New Jersey, and being a portion of Washington Road (formerly West Road) (variable width right of way) to be vacated, as shown on a map entitled "Right of Way Vacation Exhibit for a portion of Washington Avenue, Township of Stafford, Ocean County, New Jersey", prepared by Colliers Engineering & Design, dated September 27, 2023, the same also known as "Entrance Parcel Dedicated to Stafford Township" as shown on a map entitled: "Major Subdivision, "Manahawkin Village", Tax Map Lot 1.01, Block 77, Stafford Township, Ocean County, New Jersey", prepared by Owen Little & Associates, Inc., dated July 29, 1993 and revised through December 7, 1993, said map duly filed in the Ocean County Clerk's Office on December 13, 1993 as Map No. G-2499 and being more particularly bounded and described as follows:

- SOUTHWESTWARDLY along a non-tangent arc having a radius of 22.00 feet; and curving to the left, an arc distance of 16.51 feet, (Central Angle of 42°59'18"), said arc being connected by a chord bearing of S 80°04'10" W and a chord distance of 16.12 feet, along the aforesaid connecting arc, to a point of tangency in the aforesaid southerly right of way line of Washington Avenue; thence –

The following four (4) courses running along the aforesaid southerly right of way line of the aforesaid Washington Avenue:

- 6. **S 58°34'31" W, 60.00 feet**, through a portion of the aforesaid Washington Avenue, to the westerly right of way line of said Washington Avenue; thence –
- 7. **N 31°25'29" W, 86.36 feet**, along the aforesaid westerly right of way line of Washington Avenue, to the northerly right of way line of the same; thence –

The following three (3) courses running along the aforesaid northerly right of way line of the aforesaid Washington Avenue:

- NORTHEASTWARDLY along a non-tangent arc having a radius of 1,035.00 feet; and curving to the right, an arc distance of 172.20 feet; (Central Angle of 09°31'58"), said arc being connected by a chord bearing of N 52°44'51" E and a chord distance of 172.00 feet; to a point of compound curvature; thence
- 9. **NORTHEASTWARDLY** along an arc having a radius of **60.00 feet**; and curving to the left, an arc distance of **63.86 feet**; (Central Angle of 60°59'09"), said arc being connected by a chord bearing of **N 27°01'16" E** and a chord distance of **60.89 feet**, to a point of tangency; thence-
- 10. **N 26°26'17" W, 57.52 feet**, to the aforesaid southwesterly right of way line of New Jersey State Highway Route No. 72; thence –
- 11. **S 31°25'29" E, 192.99 feet**, along the aforesaid southwesterly right of way line of New Jersey State Highway Route No. 72; to the Point and Place of **BEGINNING**.
