

ORDINANCE NO. 2023-07

**AN ORDINANCE OF THE TOWNSHIP OF STAFFORD,
COUNTY OF OCEAN, STATE OF NEW JERSEY,
DESIGNATING A STOP INTERSECTION AT THE
INTERSECTION OF POLLYPOD ROAD AND S. MAIN
STREET**

NOW, THEREFORE, BE IT ORDAINED, by the governing body of the Township of Stafford, County of Ocean, State of New Jersey, as follows:

SECTION 1. Chapter 201 of the Municipal Code of the Township of Stafford, entitled “Vehicles and Traffic,” is hereby amended and supplemented so as to amend Article X, “Schedules”, § 201-27, “Schedule VIII: Stop Intersections” so as to add the following stop intersection/stop sign to Schedule VIII:

§ 201-27 Schedule VIII: Stop Intersections

Intersection	Stop Sign On
Pollypod Road and S. Main Street	Pollypod Road

SECTION 2. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 3. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

SECTION 4. The ordinance shall be published at least once in an official newspaper of the Township of Stafford at least ten (10) days prior to the time fixed for consideration of the final passage of the ordinance.


