#### **ORDINANCE NO. 2023 - 43**

# AN ORDINANCE OF THE TOWNSHIP OF STAFFORD, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE ACCEPTANCE OF AN EASEMENT THROUGH A PORTION OF BLOCK 147.09, LOT 291.

WHEREAS, Kenneth Albright and Theresa Albright (hereinafter "Property Owners" or "Grantors") is the owner of Block 147.09, Lot 291; and

WHEREAS, the Township of Stafford ("Township") has requested a 5-foot-wide drainage easement over a portion of the Property from Grantors; and

WHEREAS, Grantors have agreed to grant the easement, which is authorized to be acquired by the Township pursuant to <u>N.J.S.A</u>. 40A:12-4.

**NOW, THEREFORE, BE IT ORDAINED,** by the governing body of the Township of Stafford, County of Ocean, State of New Jersey, as follows:

**SECTION 1.** The Governing Body hereby authorizes and approves the acquisition for the purchase price of \$1.00 from Kenneth Albright and Theresa Albright, a perpetual drainage easement in and along a portion of property known as Block 147.09, Lot 291 on the Tax Map of the Township of Stafford. The easement is attached hereto and incorporated herein as Schedule A.

**SECTION 2.** That the Mayor and Township Clerk are hereby authorized and directed to execute any and all such documents providing for the Township's acquisition of interest in the Property and to undertake any and all such acts as may be necessary to effectuate the terms hereof, subject to the Township Attorney's approval of the form and substance of said documents.

**SECTION 3.** If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

**SECTION 4.** This ordinance shall take effect after second reading and publication as required by law.


