ORDINANCE NO. 2024-16

AN ORDINANCE OF THE TOWNSHIP OF STAFFORD, COUNTY OF OCEAN, STATE OF NEW JERSEY, SUPPLEMENTING CHAPTER 158 OF THE TOWNSHIP CODE, ENTITLED "PROPERTY MAINTENANCE" SO AS TO AMEND VARIOUS SECTIONS

NOW, THEREFORE, BE IT ORDAINED, by the governing body of the Township of Stafford, County of Ocean, State of New Jersey, as follows:

SECTION 1. The Township Code of the Township of Stafford is hereby supplemented as to Chapter 158, entitled "Property Maintenance," so as to amend various sections, which sections shall now read as follows:

§ 158-1 Adoption of code by reference.

The applicable provisions of the International Property Maintenance Code 2021, as determined by the Construction Official or the Zoning Officer, and all terms contained therein, except such portions as are hereinafter deleted, modified, changed or amended, are hereby adopted and incorporated as fully as if they were set forth at length herein.

§ 158-1.1 Amendment to Code.

- A. Chapter 1 entitled, "Scope and Administration", is hereby deleted in its entirety.
- B. Section 302.4 Weeds. All premises and exterior property shall be maintained free from weeds or plant growth in excess of 10 inches (254 mm). Noxious weeds shall be prohibited. Weeds shall be defined as all grasses, annual plants and vegetation, other than trees or shrubs provided; however, this term shall not include cultivated flowers and gardens.
- C. Section 302.7 Accessory Structures is revised and amended as follows: All accessory structures, including detached garages, fences, bulkheads, retaining walls and other walls, shall be maintained structurally sound and in good repair. Section 302.7 of the International Property Maintenance Code is revised and amended as follows:

All accessory structures, including detached garages, fences, bulkheads, retaining walls and other walls, shall be maintained structurally sound and in good repair.

§ 158-1.2 Amendment to Chapter 7, Fire Safety Requirements of the Code.

Section 702.1 of the International Property Maintenance Code is revised and amended as follows:

A safe, continuous and unobstructed path of travel shall be provided from any point in a building or structure to the public way. "Appropriate fire access," defined as an area 23 feet wide by 15 feet high, shall be maintained in the exterior premises of all

Said fire access shall take into account all natural and unnatural potential obstructions, including but not limited to tree limbs, utility wires and lighting fixtures. Said access is necessary to provide geometry suitable for circulation by a Township fire vehicle, such as a B-40 vehicle, as contained within the AASHTO design manual.

SECTION 2. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 3. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

SECTION 4. This ordinance shall take effect after second reading and publication as required by law.
