**ORDINANCE #2023-31**

**AN ORDINANCE AMENDING THE CODE OF THE  
TOWNSHIP OF STILLWATER BY REPEALING AND REPLACING  
THE FEE SCHEDULE FROM SECTION 5 OF CHAPTER 344  
ENTITLED “SOLID WASTE, RECYCLING”**

**BE IT ORDAINED**, by the Township Committee of the Township of Stillwater, Sussex County of Sussex, New Jersey, that Chapter 344, Section 5 “Fees” of the Code of the Township of Stillwater entitled “Solid Waste, Recycling” shall be repealed and replaced as set forth herein to increase costs with with new 2024 tipping fee.

**SECTION 1 – UPDATED FEE SCHEDULE**

Section 5 “Fee Schedule” of Chapter 344 “Solid Waste, Recycling” of the Code of the Township of Stillwater, Sussex County, New Jersey, is repealed in its entirety and replaced with the following new Section 5 – Fee Schedule:

**SECTION 5 - FEE SCHEDULE.**

<b>Fiberglass Dishwashers</b>	<b>\$15</b>
<b>TV Set</b>	<b>\$12</b>

<b>Couch</b>	<b>\$20</b>
<b>Armchair</b>	<b>\$10</b>
<b>Boxspring</b>	<b>\$15</b>
<b>Mattress</b>	<b>\$15</b>
<b>Rug</b>	<b>\$12</b>
<b>Dresser</b>	<b>\$15</b>
<b>Table</b>	<b>\$10</b>
<b>Small non-metal items under 70 lbs</b>	<b>\$6</b>
<b>Automobile tires without rims</b>	<b>\$5</b>
<b>Automobile tires with rims</b>	<b>\$6</b>
<b>Truck tires – not to exceed 1100/20</b>	<b>\$7</b>
<b>20 lb propane tank with valve</b>	<b>\$5</b>

**SECTION 2 – SEVERABILITY**

If any provision of this Ordinance or the application of this Ordinance to any person or circumstances is held invalid, the remainder of this Ordinance shall not be affected and shall remain in full force and effect.

**SECTION 3 – REPEALER**

All ordinances or parts of ordinances or resolutions that are inconsistent or in opposition to the provisions of this Ordinance are hereby repealed in their entirety.

**SECTION 4 - EFFECTIVE DATE**

This Ordinance shall take effect immediately upon adoption and publication in accordance with law.
