AMENDING CHAPTER XI: VEHICLES AND TRAFFIC OF THE BOROUGH CODE OF ORDINANCES TO MODIFY PARKING REGULATIONS ON VARIOUS STREETS

Be it ENACTED AND ORDAINED by the Council of the Borough of State College, and it is hereby Enacted and Ordained by authority of same, as follows:

SECTION 1. Amend Chapter XI, Section 319, Commuter Permit Zones. to Add:

<u>Highway</u> <u>Side</u> <u>Between</u>

Fraser Street West Nittany Avenue to 190 feet North of Fairmount Avenue

Highway	Side	Between
Fraser Street	East	Nittany to 190' north of
		Fairmont Avenue.

SECTION 2. Amend Chapter XI, Section 407b, <u>Payment Overtime Parking Unlawful</u>, and modify to:

b. Meter Bag Rental. The Borough will provide meter bags (or caps) indicating "No Parking Anytime" or "Reserved" to contractors working on properties adjacent to the meter(s), to vans of moving companies engaged in moving to media vehicles for on-site broadcasts, to service clubs and social service agencies for the provision of special-event public services, and to churches and other organizations for weddings, celebrations, or funerals.

Rental rates for meter bags shall be set by resolution of Council from time to time. Meter bags may be used from 6:00 a.m. until 10:00 p.m. No charge shall be made for service clubs or social service agencies providing special-event public services approved by the Council or the Manager or for funerals.

It is expressly prohibited for an individual with any other vehicle to park or leave a vehicle at a meter bag without the proper rental approval. Unauthorized vehicles may be towed at the vehicle owner's expense.

Rental of a meter bag shall not exempt the parker from complying with overnight parking limitations or parking restrictions due to snowfall.

SECTION 3. Amend Chapter XI, Section 507, Non-Metered Parking Facilities Established to Modify:

Deck	Location	
Barnard Lot	On the west side of North Barnard Street, in the 100 block	
Sparks Lot	On the west side of North Sparks Street, in the 100 block	

Parking in such lots or designated spaces shall be for contracted renters only, and vehicles shall be parked following posted parking sign instructions, head in, and only within the space specified by contract. Unauthorized vehicles shall be subject to fines and/or penalties, as specified in § 11-510 of this chapter, and/or removed by towing at the expense of the owner of the vehicle.

Facilities and rental rates shall be as set by resolution of Council from time to time.

Monthly rental rates are payable in advance. If payment is made after the fifth day of the month, an additional charge shall be added for such late payment.
