ORDINANCE # 19-10-2107

Code Amendments to Article III Subsection 400-6 Definitions, Article VII Subsection 400-39 & 40, Article IX Business Districts Subsection 400-54 Limited Retail Business District, and Article X Manufacturing Districts Subsections 400-59 & 60 and 400 Attachment I "Table of Special Uses"

Whereas; it is in the best interest of Stephenson County that the zoning code be updated from time to time; and

Whereas; the following changes are necessary to maintain the Stephenson County Code so to be in compliance with prevailing code and common law and general practice in the State of Illinois;

Be it therefore ordained that Subsection 400-6 Definitions be amended by adding alphabetically the following definitions:

<u>Cannabis Dispensary:</u> A facility licensed by the Department of Financial and Professional Regulation which acquires cannabis from a cultivation center, craft grower, processing organization, or another dispensary for the purpose of selling or dispensing cannabis, cannabis-infused products, cannabis seeds, paraphernalia, or related supplies under the Cannabis Regulation and Tax Act.

<u>Cannabis Processing Organization:</u> A facility licensed by the Department of Revenue (DOR) to extract constituent chemicals or compounds to produce cannabis concentrate or incorporate cannabis or cannabis concentrate into a product formulation to produce a cannabis product.

<u>Cannabis Craft Grower:</u> A facility licensed by the Department of Agriculture (DOA) to cultivate, dry, cure, and package cannabis and perform necessary activities to make cannabis available for sale at a dispensary or use at a processing organization, which may share its premises with a processing organization and/or a dispensary.

<u>Cannabis Cultivation Center:</u> A facility operated by an organization or business licensed by the DOA to cultivate, process, transport and perform other necessary activities to provide cannabis and cannabis-infused products to cannabis business establishments.

<u>Cannabis Infuser:</u> A facility operated by and organization or business that is licensed by the DOA to directly incorporate cannabis or cannabis concentrate into a product formulation to produce a cannabis infused product per the Cannabis Regulation and Tax Act, (P.A. 101-0027), as it may be amended from time-to-time, and regulations promulgated thereunder.

<u>Cannabis Transporter:</u> An organization or business that is licensed by the DOA to transport cannabis on behalf of a cannabis business establishment or a community college licensed under the Community College Cannabis Vocational Training Pilot Program, per the Cannabis Regulation and Tax Act, (P.A. 101-0027), as it may be amended from time-to-time, and regulations promulgated thereunder.
