## AN ORDINANCE AUTHORIZING THE MAYOR TO EXECUTE AGREEMENTS WITH WILLARD ASPHALT TO COMPLETE PAVING OF ROADS AND PADS AT THE CITY OF ST. ROBERT RV PARK

Be it ordained by the Board of Aldermen of the City of St. Robert as follows:

- SECTION 1. The Board of Aldermen of the City of St. Robert has been presented with Willard Asphalt's Proposal # 8855, with three options. A true copy of Proposal # 8855 is attached hereto as Exhibit A and is incorporated herein by specific reference.
- **SECTION 2.** The Mayor proposes to accept the 6" option for paving a portion of the RV Park road, in the total amount of \$170,710.00, and the 5" option for paving 9 RV Park Pads, in the total amount of \$70,610.00.
- **SECTION 3.** The Mayor further proposes that he be given discretion to approve and execute such further agreements with Willard Asphalt that are necessary to pave other previously constructed areas of the RV Park, subject to a maximum additional spending authority of \$25,000.00.
- SECTION 4. The Board of Aldermen approves and accepts the above described proposals.
- SECTION 5. The Mayor of St. Robert is authorized to execute the acceptance of the two above referenced options in Willard Asphalt's Proposal # 8855, to execute further agreements with Willard Asphalt that are necessary to finish the paving in the RV Park, up to the spending limit set out above, to legally bind the City of St. Robert to the said contracts with Willard Asphalt, and to expend City funds pursuant to the terms of the said contracts, subject to the spending limit set out in this ordinance. The City Clerk is directed to affix to the contracts the official seal of the City and attest to the same.
- SECTION 6. Regarding the contract created pursuant to Proposal # 8855 (Exhibit A), Willard Asphalt will supply to the City a payment bond in compliance with Missouri Revised Statutes § 107.170, conditional upon payment of the following:
  - a. Materials incorporated, consumed and used in connection with the construction of the work;
  - b. Insurance premiums both for compensation and for all other kinds of insurance; and
  - c. Labor performed in the work whether by subcontractor or otherwise.

Pursuant to the express provision of § 107.170, the language of any bond is deemed to contain all of the requirements and conditions imposed by the statute.
