**AN ORDINANCE AUTHORIZING THE MAYOR TO EXECUTE
AGREEMENTS WITH WILLARD ASPHALT FOR FOUR ASPHALT PROJECTS**

Be it ordained by the Board of Aldermen of the City of St. Robert as follows:


- SECTION 1.** The Board of Aldermen of the City of St. Robert has been presented with Willard Asphalt's Proposal # 9007, for a 6" mill and fill of J.H. Williamson Drive (patching approximately 340'), at a cost of \$46,030.00. A true copy of Proposal # 9007 is attached hereto as **Exhibit A** and is incorporated herein by specific reference.
- SECTION 2.** The Board of Aldermen of the City of St. Robert has been presented with Willard Asphalt's Proposal # 9008, for milling and asphalt work on the St. Robert Municipal Center parking lot, at a cost of \$138,980.00. A true copy of Proposal # 9008 is attached hereto as **Exhibit B** and is incorporated herein by specific reference.
- SECTION 3.** The Board of Aldermen of the City of St. Robert has been presented with Willard Asphalt's Proposal # 9009, for paving April Drive, at a cost of \$222,400.00. A true copy of Proposal # 9009 is attached hereto as **Exhibit C** and is incorporated herein by specific reference.
- SECTION 4.** The Board of Aldermen of the City of St. Robert has been presented with Willard Asphalt's Proposal # 9010, for paving April Drive, at a cost of \$35,830.00. A true copy of Proposal # 9010 is attached hereto as **Exhibit D** and is incorporated herein by specific reference.
- SECTION 5.** The Board of Aldermen approves and accepts the above described proposals.
- SECTION 6.** The Mayor of St. Robert is authorized to execute the acceptance of Willard Asphalt's proposals as contracts, to legally bind the City of St. Robert to the contracts, and to expend City funds pursuant to the terms of the said contracts. The City Clerk is directed to affix to the contracts the official seal of the City and attest to the same.
- SECTION 7.** Regarding the contracts created pursuant to Proposal ## 9008 and 9009 (**Exhibits B and C**) Willard Asphalt will supply to the City a payment bond in compliance with Missouri Revised Statutes § 107.170, conditional upon payment of the following:
- a. Materials incorporated, consumed and used in connection with the construction of the work;
 - b. Insurance premiums both for compensation and for all other kinds of insurance; and
 - c. Labor performed in the work whether by subcontractor or otherwise.

Pursuant to the express provision of § 107.170, the language of any bond is deemed to contain all of the requirements and conditions imposed by the statute.


SECTION 8. This ordinance shall be in full force and effect from and after its passage and approval.
