**AN ORDINANCE AMENDING THE ANNUAL BUDGET FOR THE  
FISCAL YEAR ENDING SEPTEMBER 30, 2024 AND  
APPROPRIATING FUNDS PURSUANT THERETO  
(LLEBG)**

**WHEREAS**, the LLEBG has been awarded in the amount of \$9,009.95 with no local match; and


