# AN ORDINANCE ANNEXING REAL PROPERTY OWNED BY ANDREY REZNIK CURRENTLY UNDER CONTRACT WITH MORELOCK BUILDERS & ASSOCIATES CONTINGENT UPON THE ANNEXATION OF SUCH PROPERTY FOR DEVELOPMENT INTO THE CITY OF STRAFFORD

WHEREAS, a petition for annexation has been submitted by Andrey Reznik for 3621 S State Highway 125, and the property is currently under contract with Morelock Builders contingent upon the annexation of such property for development; and

**WHEREAS,** on July 1, 2024 a properly and duly posted public hearing was held by the Board of Aldermen to act upon a voluntary annexation petition signed by the property owner of property, herein described in Section 1, requesting annexation of said property into the City of Strafford, Missouri; and

**WHEREAS**, at said public hearing, all interested persons, corporations, or political subdivisions were afforded the opportunity to present evidence regarding the proposed annexation and no objections were filed; and

WHEREAS, said property was determined to be described as adjacent and contiguous to the present corporate limits of the City of Strafford, Missouri; and

**WHEREAS,** the Board of Aldermen of the City of Strafford, Missouri, does find and determine that said annexation is reasonable and necessary to the proper development of the city and is able to furnish normal municipal services to said area within a reasonable time after annexation.
