

AN ORDINANCE OF THE CITY OF TARKIO, MISSOURI DECLARING THE RESULTS OF THE GENERAL ELECTION HELD IN THE CITY OF TARKIO, MISSOURI ON THE 4th DAY OF APRIL, 2023.

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF TARKIO, MISSOURI, AS FOLLOWS, TO WIT:

SECTION 1 WHEREAS, the Board of Aldermen of the City of Tarkio, Missouri did in compliance with Ordinance No. 105.020 and Chapter 105, Section A-D, of the Code of Ordinances of the City of Tarkio, call for an election to be held on the 5th day of April, 2022, for the purpose of submitting to the qualified voters the election of Mayor, Alderman in the North Ward, Alderman and in the South Ward.

WHEREAS, as provided by the election laws of this City, the General Election was held on the 4th day of April, 2023, and

WHEREAS, the results of said election have been certified by the County Clerk to the Board of Aldermen, and

WHEREAS, the County Clerk has examined the election returns of said General Election and the Certification of Election Results made by the County Clerk shows the following results, to-wit:
