ORDINANCE NO. 23-03**

**AN ORDINANCE AMENDING APPENDIX A
OF THE TOWN OF TAOS LAND USE DEVELOPMENT CODE
APPLICATION FEES**

WHEREAS, the Town of Taos application fees are outdated; and

WHEREAS, the Town of Taos adopted a Comprehensive Plan on March 17, 2022, that references the need to update the Land Use application fees; and

WHEREAS, the Town of Taos has a responsibility to charge application fees that are reasonable and that cover the cost of services provided by the Town; and

WHEREAS, the Town of Taos, Community & Economic Development Department, Flood Plain and GIS department addressing fees schedule shall be included;

NOW, THEREFORE, BE IT ORDAINED by the Governing Body of the Town of Taos, meeting in Regular Session this 28th day of February, that the following is hereby adopted, approved and ratified:

APPENDIX A

APPLICATION FEES

- A. Application fees established herein are not refundable. If a particular development requires more than (1) one approval, then the applicant shall pay the required application fee for each approval sought.**
- B. The Code Administrator may assign a fee to any application procedure not mentioned herein. Such application fee should be based on the fee for the most comparable application procedure listed herein.**
- C. The following fee schedule is hereby established:**
