**ORDINANCE NO. 10-2021 AMENDING SECTION 36-32 OF DIVISION 5 OF ARTICLE II OF CHAPTER 36 OF THE CODE OF THE TOWNSHIP OF TEANECK RELATING TO THE DESIGNATION OF BUS STOPS ALONG STATE HIGHWAY ROUTE NO. 4 BE IT RESOLVED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF TEANECK THAT ORDINANCE #10-2021 PASS UPON SECOND AND FINAL READING AND THAT THE TOWNSHIP CLERK IS HEREBY AUTHORIZED AND DIRECTED TO ADVERTISE THE SAME ACCORDING TO LAW AND TO PROVIDE THE APPROPRIATE NOTICES IN ACCORDANCE WITH LAW.**

BE IT ORDAINED by the Township Council of the Township of Teaneck, County of Bergen and State of New Jersey as follows:

SECTION 1. Paragraph (c), State Roads, of Section 36-32, Designation, of Division 5, Bus Stops, of Article II, Parking, of Chapter 36, Traffic, of the Code of the Township of Teaneck is hereby amended to read in full as follows:

**(c) STATE ROADS**

(1) Along Route NJ 4, eastbound, on the southerly side at:

A. Between River Road Bridge No. 166 and River Road (CR 41) - (mid-block) (NJ Transit ID# 13729)

Beginning at a point 600 feet west of the westerly curb line of River Road (CR 41) and extending 135 feet westerly therefrom.

B. Garrison Avenue - (far side) (NJ Transit ID# 13730)

Beginning at the easterly curb line of Garrison Avenue and extending 100 feet easterly therefrom.

C. Between Queen Anne Road and Margaret Street - (mid-block) ( NJ Transit ID# 13731)

Beginning at a point 460 feet west of the westerly curb line of Margaret Street and extending 135 feet westerly therefrom.

D. Margaret Street - (far side) ( NJ Transit ID # 13732)

Beginning at the easterly curb line of Margaret Street and extending 100 feet easterly therefrom.

E. Between the Teaneck Road (CR 39) interchange ramps - (mid-block) (NJ Transit ID# 13733)

Beginning at a point 30 feet east of the easterly curb line of the ramp connecting Teaneck Road (CR 39) southbound and Route NJ 4, eastbound. (SRI Ramp ID # B100760).

F. Phelps Road - (far side) (NJ Transit ID# 13734)

Beginning at the easterly curb line of Phelps Road and extending 100 feet easterly therefrom.

G. Between Webster Avenue and Overpeck Creek - (mid-block) (NJ Transit ID# 13735)

Beginning at a point 465 feet east of the easterly curb line of Webster Avenue and extending 135 feet easterly therefrom.

(2) Along Route NJ 4, westbound, on the northerly side at:

A. Between Decatur Avenue and Webster Avenue - (mid-block) (NJ Transit ID # 13736)

Beginning at a point 20 west of the westerly curb line of Decatur Avenue and extending 135 feet westerly therefrom.

B. Congress Avenue - (near side) (NJ Transit ID# 13737)

Beginning at the easterly curb line of Congress Avenue and extending 105 feet easterly therefrom.

C. Between the Teaneck Road interchange ramps - (mid-block) (NJ Transit ID# 13738)

Beginning at a point 30 feet west of the westerly curb line of the ramp connecting Teaneck Road (CR 39), northbound and Route NJ 4, westbound. (SRI Ramp ID # Y100770).

D. Margaret Street - (far side) (NJ Transit ID# 13739)

Beginning at the westerly curb line of Margaret Street and extending 100 feet westerly therefrom.

E. Belle Avenue - (far side) (NJ Transit ID# 13740)

Beginning at the westerly curb line of Belle Avenue and extending 100 feet westerly therefrom.

F. River Road Ramp - (far side) (NJ Transit ID# 13741)

Beginning at the westerly curb line of River Road Ramp and extending 100 feet westerly therefrom.

SECTION 2. Inconsistency. All ordinances or parts of ordinances contrary to or inconsistent with the provisions of this ordinance are hereby superseded to the extent of such inconsistency. Any approved bus stop locations or traffic regulations in conflict with or inconsistent with the provisions of this ordinance are hereby rescinded to the extent of such conflict or inconsistency.

SECTION 3. Severability. If any section, sentence, clause or other portion of this ordinance, or the application thereof to any person or circumstance, shall be adjudged by a court of competent jurisdiction to be invalid or unconstitutional, such judgment shall not affect, impair or repeal the remainder of this ordinance.

SECTION 4. Effective Date. This ordinance shall take effect twenty days after passage and publication, except as otherwise provided by law.
