AN ORDINANCE AMENDING SECTION 36-11.2 OF DIVISION 1 OF ARTICLE II OF CHAPTER 36, ENTITLED “TRAFFIC,” OF THE TOWNSHIP CODE ADDING RESTRICTED ON-STREET PARKING SPACES FOR HANDICAPPED AT 42 EDGEMONT PLACE

BE IT ORDAINED by the Township Council of the Township of Teaneck, Bergen County, New Jersey, as follows:

SECTION 1. Section 36-11.2 “Establishment of restricted on-street parking spaces for handicapped” of Division 1 “Generally” of Article II “Parking” of Chapter 36 entitled “Traffic,” of the Code of the Township of Teaneck is hereby amended to add thereto the following streets or portions thereof:

Edgemont Place, South side, from a point approximately 200 feet east of the easterly curbline of Prince Street and extending 20 feet east therefrom.

SECTION 2. Inconsistency. All ordinances or parts of ordinances contrary to or inconsistent with the provisions of this ordinance are hereby superseded to the extent of such inconsistency.

SECTION 3. Severability. If any section, sentence, clause or other portion of this ordinance, or the application thereof to any person or circumstance, shall be adjudged by a court of competent jurisdiction to be invalid or unconstitutional, such judgment shall not affect, impair or repeal the remainder of this ordinance.

SECTION 4. Effective Date and Expiration Date. This ordinance shall take effect twenty days after passage and publication, except as otherwise provided by law. This ordinance shall expire on a date two years from the effective date of the within ordinance, unless sooner repealed or further extended.
