**ORDINANCE NO. 2-2024 AMENDING THE TOWNSHIP CODE FOR THE TOWNSHIP OF TEANECK TO REVISE MEMBERSHIP ON THE SOCIAL SERVICES ADVISORY BOARD BE IT RESOLVED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF TEANECK THAT ORDINANCE #2-2024 PASS UPON SECOND AND FINAL READING AND THAT THE TOWNSHIP CLERK IS HEREBY AUTHORIZED AND DIRECTED TO ADVERTISE THE SAME ACCORDING TO LAW AND TO PROVIDE THE APPROPRIATE NOTICES IN ACCORDANCE WITH LAW.**

**WHEREAS**, the Mayor and Township Council for the Township of Teaneck (the “Township”) wish to increase participation by Township residents in the Township’s advisory boards; and

**WHEREAS**, the Social Services Advisory Board (“SSAB”) is comprised of six residents and the Health Officer; and

**WHEREAS**, the Mayor and Township Council believe that permitting the Social Services Coordinator to participate would bring a useful set of skills to the SSAB.

**NOW, THEREFORE, BE IT ORDAINED** by the Township Council that:

**SECTION I.** Chapter 2, “Charter/Administrative Code,” of the Township Code of the Township of Teaneck is hereby amended to read as follows:

**Sec. 2-148. Establishment of Council’s advisory boards.**

(h) A Social Services Advisory Board is hereby created.

- (1) Purpose. The purpose of the Board is to advise the Council and the Social Services Coordinator with respect to the social services programs available to the residents of the Township of Teaneck.
- (2) Membership. Membership on the Board shall consist of seven members, six of whom shall be residents of the Township and one of whom shall be the Social Services Coordinator of the Township of Teaneck.

**SECTION II.** All ordinances or parts of ordinances in conflict or inconsistent with any part of this Ordinance are hereby repealed to the extent that they are in conflict or inconsistent.

**SECTION III.** If any section, provision, or part of provision of this Ordinance shall be held to be unenforceable or invalid by any court, such holding shall not affect the validity of this Ordinance, or any part thereof, other than the part so held unenforceable or invalid.

**SECTION IV.** This Ordinance shall take effect after passage and publication in the manner provided by law.
