**ORDINANCE NO. 14-2024 AMENDING SECTION 36-11.2 OF CHAPTER 36 OF THE TOWNSHIP CODE FOR THE TOWNSHIP OF TEANECK ADDING A RESTRICTED ON-STREET PARKING SPACE FOR HANDICAPPED PARKING AT 1494 CHAMPLIN SQUARE BE IT RESOLVED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF TEANECK THAT ORDINANCE #14-2024 PASS UPON SECOND AND FINAL READING AND THAT THE TOWNSHIP CLERK IS HEREBY AUTHORIZED AND DIRECTED TO ADVERTISE THE SAME ACCORDING TO LAW AND TO PROVIDE THE APPROPRIATE NOTICES IN ACCORDANCE WITH LAW.**

**NOW, THEREFORE, BE IT ORDAINED** by the Township Council that:

**SECTION I.** Section 36-11.2 “Establishment of restricted on-street parking spaces for handicapped” of Chapter 36 of the Township Code of the Township of Teaneck is hereby amended to add the following streets or portions thereof as follows:

*South Side of Howland Avenue. The first sign should be installed from a point twelve feet (12ft) west of the westerly curb line of Champlin Square and the second sign to a point twenty feet (20ft) south thereof*

**SECTION III.** All ordinances or parts of ordinances in conflict or inconsistent with any part of this Ordinance are hereby repealed to the extent that they are in conflict or inconsistent.

**SECTION IV.** If any section, provision, or part of provision of this Ordinance shall be held to be unenforceable or invalid by any court, such holding shall not affect the validity of this Ordinance, or any part thereof, other than the part so held unenforceable or invalid.

**SECTION V.** This Ordinance shall take effect after passage and publication in the manner provided by law.
