ORDINANCE NO. 16-2024 AMENDING THE TOWNSHIP CODE TO REVISE PARKING LAWS ON AYERS COURT BE IT RESOLVED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF TEANECK THAT ORDINANCE #16-2024 PASS UPON SECOND AND FINAL READING AND THAT THE TOWNSHIP CLERK IS HEREBY AUTHORIZED AND DIRECTED TO ADVERTISE THE SAME ACCORDING TO LAW AND TO PROVIDE THE APPROPRIATE NOTICES IN ACCORDANCE WITH LAW.

WHEREAS, the Mayor and Township Council of the Township of Teaneck is charged with establishing and maintaining safe passage and safe conditions within the Township; and

WHEREAS, the Mayor and Township Council have therefore determined that an ordinance modifying where and when vehicles may park in the Township is in the best interests of the health, safety, and welfare of the residents of the Town.

NOW, THEREFORE, BE IT ORDAINED, as follows:

SECTION I. Section 36-21, “Time Limited Parking,” of Article II, “Parking,” of Chapter 36, “Traffic,” of the Township Code shall be and is hereby amended by the addition of the following:

Sec. 36-21. Time Limited Parking

No person shall park a vehicle longer than the time limit specified between the hours set forth and on the days indicated on the following locations:

| Street Name | Side | Location | Time Limit | Hours | Days |
|----------------------|------|--|------------|------------------------|---|
| Ayers Court 145 feet | East | 145 feet east of Queen Anne Road toward Lozier Place | 2 hours | 8:00 a.m. to 5:00 p.m. | All days except Saturdays, Sundays, and holidays. |

SECTION II. All ordinances or parts of ordinances in conflict or inconsistent with any part of this Ordinance are hereby repealed to the extent that they are in conflict or inconsistent.

SECTION III. If any section, provision, or part of provision of this Ordinance shall be held to be unenforceable or invalid by any court, such holding shall not affect the validity of this Ordinance, or any part thereof, other than the part so held unenforceable or invalid.

SECTION IV. This Ordinance shall take effect after passage and publication in the manner provided by law.
