ORDINANCE NO. 1 of 2023

AN ORDINANCE OF THE BOROUGH OF TRAFFORD, ALLEGHENY AND WESTMORELAND COUNTIES, PENNSYLVANIA, MAKING VARIOUS REVISIONS TO THE CODIFIED ORDINANCES OF THE BOROUGH OF TRAFFORD INCLUDING AMENDING SCHEDULE XIV: "PARKING PROHIBITED AT ALL TIMES" AS SET FORTH IN THE CODIFIED ORDINANCES OF THE BOROUGH OF TRAFFORD AT CHAPTER 188, ARTICLE VIII § 188-62 TO ADD THE SOUTH SIDE OF MEADOW STREET TO THE LIST OF STREETS WHERE PARKING IS PROHIBITED AT ALL TIMES AND TO AUTHORIZE THE PLACEMENT OF NO PARKING SIGNS ALONG SAME, AND AMENDING CHAPTER 64, ARTICLE II §64-4 TO CONFIRM THAT A TICKET MACHINE IS A DEVICE REQUIRING A PERMIT AND §64-7 REGARDING THE REQUIRED LICENSE FEES.

WHEREAS, the Borough of Trafford further desires to amend Chapter 188 Article VIII § 188-62, Schedule XIV to add the South side of Meadow Street as prohibited parking at all times and to authorize the placement of no parking signs; and

WHEREAS, the Borough of Trafford further desires to amend Chapter 64 Article II §64-4 to confirm that a ticket machine is a device requiring a permit and to amend; and to amend §64-7 regarding the required license fees

NOW, THEREFORE, BE IT ORDAINED and it is hereby ordained and enacted by the Borough Council of the Borough of Trafford, Allegheny and Westmoreland Counties at a duly convened meeting, quorum present as follows:

SECTION I. AMENDING CHAPTER 188 ARTICLE VIII § 188-62, SCHEDULE XIV: PARKING PROHIBITED AT ALL TIMES

The Borough of Trafford hereby amends Chapter 188, Article VIII §188-62, Schedule XIV: Parking prohibited at all times to add the South side of Meadow Street as prohibited parking at all times as follows:

Name of Street	Side	Location
Meadow Street	South	Entire length

SECTION III. AMENDING CHAPTER 64 ARTICLE II §64-4 LICENSES REQUIRED FOR PREMISES AND DEVICES TO CONFIRM THAT A TICKET MACHINE IS A DEVICE REQUIRING A PERMIT

The Borough of Trafford hereby amends Chapter 64, Article II to add §64-4 Licenses required for premises and devices which shall read as follows to confirm that a ticket machine is a device that requires a permit:

§64-4 Licenses require for premises and devices.

No person, individual, firm, partnership, corporation company or other entity shall operate any premises wherein there is located any machine, mechanical device, electronic device or electromechanical device used directly or indirectly for chance, skill or amusement or for the playing of games, for use as a game, entertainment or amusement, including, but not limited to, such devices as marble machines, bowling machines, photoelectric target shooting machines, electronic video games, air hockey games, football games, baseball games, musical devices commonly known as "jukeboxes", ticket generating or delivering devices, or any game, operation, device or transaction similar thereto under whatever name, without first obtaining a license for each such premises and machine or device from the Borough of Trafford.

SECTION III. AMENDING CHAPTER 64 ARTICLE II §64-4 FEES

The Borough of Trafford hereby amends Chapter 64, Article II to add §64-7 to eliminate the annual fee and to read as follows:

§64-7 Fees.

The fee for licenses required by this Ordinance for each particular amusement device shall be the sum as set forth from time to time by Resolution of the Borough Council.

SECTION IV. REPEALS

All other ordinances of the Borough of Trafford which conflict with this Ordinance are hereby repealed to extent of such conflict.

SECTION V. SEVERABILITY

It is hereby declared to be the intention of the Council of the Borough of Trafford that the several provisions of this Ordinance are separable. If any Court of competent jurisdiction shall declare any words, sentences, sections, or provisions of this Ordinance to be invalid, such a ruling shall not affect any other words, sentences, sections, or provisions of this Ordinance not specifically included in said ruling.


SECTION VI. EFFECTIVE DATE


This ordinance shall take effect immediately upon its approval.
