

# BOROUGH OF TRAFFORD

## ORDINANCE NO. 6-2024

**AN ORDINANCE OF THE BOROUGH OF TRAFFORD, COUNTY OF ALLEGHENY AND WESTMORELAND, COMMONWEALTH OF PENNSYLVANIA, AMENDING SCHEDULE XIV: "PARKING PROHIBITED AT ALL TIMES" AS SET FORTH IN THE CODIFIED ORDINANCES OF THE BOROUGH OF TRAFFORD AT CHAPTER 188, ARTICLE VIII § 188-62 TO ADD NO PARKING ON EITHER SIDE OF THE 100 AND 200 BLOCK OF WALLACE STREET NO PARKING ON THE NORTH BOUND SIDE OF WESTMORELAND STREET FROM 1<sup>ST</sup> STREET TO 4<sup>TH</sup> STREET AND TO AUTHORIZE THE PLACEMENT OF NO PARKING SIGNS ALONG SAME.**

**WHEREAS**, the Borough of Trafford desires to amend Chapter 188 Article VIII § 188-62, Schedule XIV to add both sides of Wallace Street in the 100 and 200 blocks as prohibited parking at all times and the northbound side of Westmoreland Road (the railroad track side) from 1<sup>st</sup> Street to 4<sup>th</sup> Street as prohibited parking at all times and to authorize the placement of no parking signs along same; and

**NOW, THEREFORE, BE IT ORDAINED** and it is hereby ordained and enacted by the Borough Council of the Borough of Trafford, Allegheny and Westmoreland Counties at a duly convened meeting. Quorum present as follows:

### **SECTION I. AMENDING CHAPTER 188 ARTICLE VIII § 188-62, SCHEDULE XIV: PARKING PROHIBITED AT ALL TIMES**

The Borough of Trafford hereby amends Chapter 188, Article III § 188-62, Schedule XIV: Parking prohibited at all times to include as prohibited parking at all times as follows:

Name of Street	Side	Location
Wallace Street	Both	100 and 200 Blocks
Westmoreland	Northbound (Railroad tracks side).	1st Street-4th Street

### **SECTION II. REPEALS**

All other ordinances of the Borough of Trafford which conflict with this Ordinance are hereby repealed to extent of such conflict.

**SECTION III. SEVERABILITY**



**SECTION VI. EFFECTIVE DATE**

This Ordinance shall take effect immediately upon its approval.


