

BOROUGH OF TRAFFORD

ORDINANCE NO. 3-2025

AN ORDINANCE OF THE BOROUGH OF TRAFFORD, COUNTY OF ALLEGHENY AND WESTMORELAND, COMMONWEALTH OF PENNSYLVANIA, AMENDING PART I, CHAPTER 43, § 43-2 & § 43-3 OF THE CODIFIED ORDINANCES OF THE BOROUGH OF TRAFFORD FORMALLY REDUCING THE RECREATION BOARD FROM SEVEN MEMBERS TO FIVE MEMBERS AND CONFIRMING THE CURRENT TERMS.

WHEREAS, On April 12, 1994, the Borough of Trafford enacted Ordinance 645, establishing a Recreation Board in the Borough; and

WHEREAS, on February 19, 2008, the Borough of Trafford enacted Ordinance making various changes to the Recreation Board, including its composition as a seven member board; and

WHEREAS, the provisions regarding the Recreation Board are now contained within the Codified Ordinances of the Borough of Trafford in Part I, Chapter 43; and

WHEREAS, the Borough of Trafford desires to amend Chapter 43 to formally reduce the Recreation Board from seven member to five members and to confirm the terms of the current board members.

NOW, THEREFORE, BE IT ORDAINED and it is hereby ordained and enacted by the Borough Council of the Borough of Trafford, Allegheny and Westmoreland Counties at a duly convened meeting. Quorum present as follows:

SECTION I. AMENDING PART I, CHAPTER 43, § 43-2 OF THE CODIFIED ORDINANCES

The Borough of Trafford hereby amends Part I, Chapter 42, § 43-2 which shall read as follows:

§ 43-2 Composition

The Borough of Trafford has reduced the Recreation Board so that the Borough of Trafford Recreation Board shall henceforth consist of five members, all of whom shall be residents of the Borough of Trafford.

SECTION II. AMENDING PART I, CHAPTER 43, § 43-4 OF THE CODIFIED ORDINANCES

The Borough of Trafford hereby amends Part I, Chapter 42, § 43-4 A. and § 43-4 B. which shall now read as follows:

§ 43-4 Appointment of members; terms; vacancies.

- A. The members of the Borough of Trafford Recreation Board shall be appointed by the Council of the Borough of Trafford. The expiration date of the terms of the current Recreation Board members are confirmed as follows:
- (1) The term of one member of the Recreation Board shall expire on December 31, 2025.
 - (2) The term of one member of the Recreation Board shall expire on December 31, 2026,
 - (3) The terms of three members of the Recreation Board shall expire on December 31, 2027.
- B. Upon expiration of the current terms, all subsequent terms shall be for three year durations commencing the first Monday in January and expiring three years later on December 31.

SECTION III. AFFIRMANCE OF REMAINDER OF PROVISIONS OF CHAPTER 43.

All other provisions of Chapter 43, Recreation Board in the Codified Ordinances of the Borough of Trafford are hereby affirmed and remain in full force and effect.

SECTION IV. REPEALS

Any ordinances of the Borough of Trafford which conflict with this Ordinance are hereby repealed to extent of such conflict.

SECTION V. SEVERABILITY

It is hereby declared to be the intention of the Council of the Borough of Trafford that the several provisions of this Ordinance are separable. If any Court of competent jurisdiction shall declare any words, sentences, sections, or provisions of this Ordinance to be invalid, such a ruling shall not affect any other words, sentences, sections, or provisions of this Ordinance not specifically included in said ruling.

SECTION VI. EFFECTIVE DATE

This Ordinance shall take effect immediately upon its approval.




