

RESOLUTION NO. R-14-2024

**A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE TOWNSHIP OF
UNITY, COUNTY OF WESTMORELAND, COMMONWEALTH OF
PENNSYLVANIA ESTABLISHING A ROAD CLOSURE SCHEDULE FOR THE
2024 WESTMORELAND COUNTY AIR SHOW**

WHEREAS, the Westmoreland County Airport Authority (WCAA) will conduct the 2024 Westmoreland County Airshow at the Arnold Palmer Regional Airport from August 15, 2024, to August 18, 2024; and

WHEREAS, the WCAA has requested permission to close certain Township Roads during the Airshow to ensure public safety during high-speed aerobic jet operations prior to and during the air show; and

WHEREAS, the Board of Supervisors adopt this Resolution to permit such road closures subject to the terms set forth therein, to protect the public health, safety and welfare;

NOW, THEREFORE, WITH THE FOREGOING RECITALS BEING INCORPORATED HEREIN BY REFERENCE THERETO, THE BOARD OF SUPERVISORS HEREBY RESOLVE AS FOLLOWS:

1. That the following Township roads shall be subject to closure at the times set forth hereafter:
 - a. Airport Road from SR 981 to Earhart Road;
 - b. Earhart Road from Airport Road to St. Xavier Road;
 - c. St. Xavier Road from Route 30 to Haines Road; and
 - d. Haines Road from Airport Road to Sessi Road.

2. The dates and times such closures are permitted shall be as follows:
 - a. Thursday, August 15, 2024, from 12:00 to 2:00 p.m., and 3:00 to 4:00 p.m.
 - b. Friday, August 16, 2024, from 1:00 to 4:00 p.m.; and
 - c. Both Saturday August 17, 2024, and Sunday, August 18, 2024, from 8:00 a.m. to 4:30 p.m.


3. The WCAA shall be responsible for traffic control associated with all road closures and shall staff and monitor all affected sites through the Civil Air Patrol.

4. The WCAA shall carry liability insurance providing coverage for all bodily injury and property loss claims arising from or which could arise from such road closures with limits of not less than \$500,000.00 per occurrence. The Township shall be named as an additional insured on such policy and the WCAA shall provide an ACORD Certificate of Insurance as evidence of same. By approval of this Resolution, the Township acknowledges its receipt of such Certificate.

THIS RESOLUTION IS DULY ADOPTED BY THE BOARD OF SUPERVISORS OF THE TOWNSHIP OF UNITY AT A DULY ADVERTISED PUBLIC MEETING HELD THE 11th DAY OF JULY 2024 AND SHALL BE EFFECTIVE IMMEDIATELY.
