ORDINANCE #2023-13

AN ORDINANCE OF THE TOWNSHIP OF UNION, COUNTY OF HUNTERDON, STATE OF NEW JERSEY, AMENDING § 2-14.10 OF THE TOWNSHIP CODE TO AUTHORIZE ONLY CERTIFIED ACTIVE FIREFIGHTERS, EMTS AND CERTIFED PARAMEDICS, AND JUNIOR FIREFIGHTERS, TO RIDE ON OR IN ANY FIRE APPARATUS, ENGINE OR VEHICLE.

WHEREAS, § 2-14.10 of the Code of the Township of Union governs prohibited uses of Fire Department vehicles and identifies who may ride on or in such vehicles; and

WHEREAS, the Township Committee desires to amend the Code to clarify which emergency service personnel are authorized to ride on or in any fire apparatus, engine or vehicle.

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Union, County of Hunterdon, State of New Jersey, as follows:

SECTION 1. Chapter 2, Administration, Article IV, Departments of the Municipal Government, § 2-14, Fire Department, § 2-14.10, Prohibited Uses of Fire Department Vehicles, of the Township Code is hereby amended to read as follows:

§ 2-14.10 Prohibited Uses of Fire Department Vehicles. [Ord. No. 2016-7]

- a. The use of Fire Company vehicles, apparatus, or equipment for private use, profit, benefit or advantage is prohibited, except in case of fire or other emergency which shall be immediately reported to Hunterdon County 911. Violation of this section shall be cause for discipline as provided in this section.
- b. Only certified active firefighters, EMTs and/or certified paramedics shall be permitted to ride on or in any fire apparatus, engines and/or vehicles. Junior firefighters shall be permitted to ride in fire apparatus, engines and/or vehicles. Violation of this section shall be cause for discipline as provided in this chapter.
