## EXHIBIT A

# § A2.008 Filing fee for amending plats, license agreements, requests for special sign districts, and submissions for planning and zoning commission and board of adjustment hearings.

- a. The fee to be paid by applicants who request a plat from the building department shall be three hundred dollars (\$300.00) per request.
- b. The fee to be paid by applicants who request a license agreement from the city shall be two hundred fifty dollars (\$250.00) per request.
- c. The fee to be paid by applicants who request a special sign district shall be three hundred dollars (\$300.00) per request.
- d. The fee to be paid by applicants who request a hearing before the Planning and Zoning Commission shall be three hundred dollars (\$300.00) per application.
- e. The fee to be paid by applicants who request a hearing before the Board of Adjustment shall be five hundred dollars (\$500.00) per application.
- f. The fee to be paid by applicants who request an abandonment shall be \$500 per request.

## § A4.008 Alarm permit/direct alarm monitoring fees.

- a. The city shall charge a fee of \$50.00 (fifty dollars) for the initial alarm permit. Each year thereafter, alarm permit holders shall pay an annual fee of \$48.00 (forty-eight dollars) due on the anniversary date of their original application or included on their utility bill at the rate of \$4.00 (four dollars) per month. Alarm permits are not transferable.
- b. Each alarm permit holder subscribing to the city's basic digital-dialer direct alarm monitoring system shall pay a fee of \$300.00 per year. This basic monitoring may be by digital-dialer, internet service provider, or by a wireless radio. This fee will be paid in 12 monthly installments of \$25.00 each. An additional fee of \$7.00 per month will be charged for a secondary wireless or back-up transmitting device for direct alarm monitoring. The monitoring fee for digital-dialer or internet service provider and back-up radio will be \$384.00 per year paid in 12 monthly installments of \$32.00.
- c. Ancillary, or enhanced alarm services will be charged as follows:

- d. A penalty shall be imposed on a permit holder for the signaling of a false burglary alarm as follows:
  - a) \$50.00 for each false alarm if the location has had more than three but fewer than six other false alarms in the preceding 12-month period;
  - b) \$75.00 for each false alarm if the location has had more than five but fewer than eight other false alarms in the preceding 12-month period; or
  - a. \$100.00 for each false alarm if the location has had eight or more other false alarms in the preceding 12-month period.
