

RESOLUTION NO. 23-022

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF UNIVERSITY PARK, TEXAS, AMENDING RESOLUTION 23-002, MASTER FEE SCHEDULE, SUBSECTION A3.001 – WATER METER SECURITY AND A3.002 RECONNECTION OF WATER SERVICE FOLLOWING CUT-OFF FOR NON-PAYMENT OF WATER BILLS AS DETAILED ON EXHIBIT A AND PROVIDING AN EFFECTIVE DATE.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF UNIVERSITY PARK, TEXAS:

SECTION 1. That Appendix A of the Code of Ordinances (the “Fee Schedule”) is hereby amended, as follows in Exhibit A.

SECTION 2. This Resolution shall take effect as of January 1, 2024 and it is accordingly so resolved.

EXHIBIT A

Fee Schedule

The following schedule of fees is compiled from various ordinances, resolutions, etc., and is included for reference purposes only. The fees contained herein may be amended from time to time, and do not necessarily require an amending ordinance to do so.

ARTICLE A3.00

UTILITIES

§ A3.001 Water meter security.

- (a) Before water service is furnished to a consumer at any address, the consumer shall be required, upon making application for such service, to deposit with the manager of the utility billing office, deposits amounting to the following for each meter:

<u>Meter size</u>	<u>Status</u>	<u>Fee</u>
5/8" to 1.5" meters	Homeowner	\$75.00
5/8" to 1.5" meters	Renter	\$100.00
Meters larger than 1.5"	All	\$200.00
Hydrant meter	Installation	\$40.00
Hydrant meter	Refundable deposit	\$1,500.00

- (b) The deposit for apartments or duplexes that are not individually metered will be seventy-five dollars (\$75.00) per unit. For example, the deposit for a four-unit apartment will be three hundred dollars (\$300.00).
- (c) In the case of business institutions, the manager of the utility billing office may require a deposit equal to three times the average monthly bill on such premises.

§ A3.002 Reconnection of water service following cut-off for nonpayment of water bills.

When water is cut off because of nonpayment, the manager of the utility billing office shall not permit the water or sewer services to be resumed until the full amount delinquent, the ten percent (10%) penalty, and a collection or reconnection charge of fifty dollars (\$50.00) is paid. Such amount shall be paid at the utility billing office if reconnected during normal office hours. The reconnect charge shall increase to one hundred dollars (\$100.00) if the request for service is made after hours.
