ORDINANCE No. 556

AN ORDINANCE OF THE TOWNSHIP OF UPPER PROVIDENCE, COUNTY OF DELAWARE, COMMONWEALTH OF PENNSYLVANIA, AMENDING THE CODE OF UPPER PROVIDENCE TOWNSHIP, CHAPTER 440 – PARKING GENERALLY, SECTION 440.01 SUBPART (E) RESTRICTING PARKING ON WEST LINCOLN STREET (SOUTH SIDE) AND INCREASING AVAILABLE PARKING ON WEST LINCOLN STREET (NORTH SIDE).

WHEREAS, the Township of Upper Providence is a municipal corporation organized and existing under the laws of the Commonwealth of Pennsylvania; and

WHEREAS, the Legislature of the Commonwealth and the Home Rule Charter vests the Township of Upper Providence with the power and the authority to make and adopt all such ordinances, bylaws, rules and regulations not inconsistent with or restrained by the Constitution and laws of the Commonwealth, as it is expedient or necessary for the proper management, care and control of, inter alia, the Township’s finances, the maintenance of peace, good government, safety and welfare of the Township, its trade, commerce and manufactures.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED, by the Township Council of the Township of Upper Providence as follows:

SECTION 1: Amendments to Parking Ordinance.

Chapter 440, Section 440.01 of the Code of the Township of Upper Providence, entitled “Parking prohibited at certain locations” at subpart (e) is hereby amended to amend the two following line items for “West Lincoln Street – North” and “West Lincoln Street – South” to read as follows:

Highway	Side	Location
West Lincoln Street	North	From Park Avenue to Orange Street except for an existing 20’ wide parking area in front of 17 Lincoln St (between the

driveways) and 40' wide parking area in front of 19-21 Lincoln St. (west of the driveway at 19 Lincoln St.).¹

West Lincoln Street	South (no parking)	Extending 100 feet West from its intersection with Park Avenue.
	South (two-hour limited parking)	From Orange Street to Olive Street.

1 – The Postal Service appears to have misnumbered these properties as 17-21 E. Lincoln St. According to County tax records they are listed simply as 17-21 Lincoln St. Township records list the block as the eighth block of W. Lincoln Street.

SECTION 2: Other Ordinances.

Nothing in this Ordinance shall be interpreted to relieve any individual from compliance with all other ordinances, resolutions, laws and regulations of the Township, of the County of Delaware, the Commonwealth of Pennsylvania or the United States.

SECTION 3. Repealer.

All ordinances, resolutions and parts of ordinances and resolutions inconsistent herewith, are hereby repealed.

SECTION 4. Severability.

The provisions of this ordinance are severable, and if any section, sentence, clause, part, or provision hereof shall be held illegal, invalid or unconstitutional by any court of competent jurisdiction, such decision of the court shall not affect or impair the remaining sections, sentences, clauses, or parts of this Ordinance. It is hereby declared to be the intent of the Township Council that this Ordinance would have been adopted if such illegal, invalid, or unconstitutional sections, sentence, clause, part, or provision had not been included therein.

SECTION 5. Adoption.

This ordinance shall become effective five (5) business days after passage.
