

**TOWNSHIP OF UPPER FREEHOLD  
ORDINANCE NUMBER 323-23**

**CAPITAL ORDINANCE PROVIDING FOR VARIOUS GENERAL  
CAPITAL IMPROVEMENTS AND ACQUISITION AND  
INSTALLATION OF VARIOUS EQUIPMENT, BY AND IN THE  
TOWNSHIP OF UPPER FREEHOLD, IN THE COUNTY OF  
MONMOUTH, STATE OF NEW JERSEY; APPROPRIATING  
\$300,000 THEREFOR FROM THE CAPITAL IMPROVEMENT  
FUND TO PAY FOR THE COST THEREOF**

**WHEREAS**, the Township of Upper Freehold, in the County of Monmouth, State of New Jersey (the "Township"), wishes to undertake various general capital improvements and the acquisition and installation, as applicable, of various equipment in and throughout the Township including, but not limited to, the acquisition of radios for the Fire Department (\$110,000); and the construction of a salt barn (\$190,000) (collectively, the "Improvements"); and

**WHEREAS**, the cost of the Improvements is estimated to be \$300,000; and

**WHEREAS**, the Township desires to authorize the appropriation and expenditure of \$300,000 from the Capital Improvement Fund to undertake the Improvements.

**BE IT ORDAINED AND ENACTED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF UPPER FREEHOLD, IN THE COUNTY OF MONMOUTH, STATE OF NEW JERSEY** (a majority of the full membership thereof affirmatively concurring), **AS FOLLOWS:**

**SECTION 1.** The capital improvements or purposes described below are hereby authorized as general capital improvements to be undertaken by the Township. For said improvements or purposes, there is hereby appropriated the amount of \$300,000 from the Capital Improvement Fund to undertake various general capital improvements and the acquisition and installation, as applicable, of various equipment in and throughout the Township including, but not limited to, the acquisition of radios for the Fire Department (\$110,000); and the construction of a salt barn (\$190,000).

**SECTION 2.** The expenditure of the \$300,000 consisting of an appropriation of \$300,000 from the Capital Improvement Fund for the Improvements set forth in Section 1 hereof is

hereby authorized and approved. The Mayor, the Clerk, the Chief Financial Officer and any other official/officer of the Township are each hereby authorized and directed to execute, deliver and perform any agreement to undertake the improvement or purpose set forth herein and to effectuate the transaction contemplated hereby.

**SECTION 3.** The capital budget of the Township is hereby amended to conform with the provisions of this capital ordinance to the extent of any inconsistency herewith and a resolution in the form promulgated by the Local Finance Board showing full detail of the amended capital budget and capital programs as approved by the Director of the Division of Local Government Services, New Jersey Department of Community Affairs is on file in the Office of the Clerk and is available for public inspection.

**SECTION 4.** This ordinance shall take effect immediately after final adoption as described in N.J.S.A. 40:49-2.
