ORDINANCE NO. 013-2024

RE: AN ORDINANCE AMENDING CHAPTER 8 (ANIMAL CONTROL) OF THE CODE OF UPPER TOWNSHIP

BE IT ORDAINED by the Township Committee, in the Township of Upper, County of Cape May and State of New Jersey, as follows:

SECTION 1. Chapter 8 (entitled "Animal Control") of the Revised General Ordinances of the Township of Upper, also known as the Code of Upper Township, shall be amended and supplemented as hereinafter provided:

Add the following to Chapter 8, Section 6:

8-6 ENFORCEMENT.

8-6.4. Notice of Violation Citation.

Notwithstanding the duties and powers granted to the Certified Animal Control Officer, violations of this Chapter may also be enforced by the issuance of a Notice of Violation citation issued by the New Jersey State Police, Township Code Enforcement Officer, or any other person who actually observes or witnesses a violation.

Revise Chapter 8, Section 17 as follows:

8-7 VIOLATIONS AND PENALTIES.

Violations of this Chapter shall be punishable as follows:

- a. First offense, in any twelve-month period, a fine of not less than \$100;
- b. Second offense, in any twelve-month period, a fine of not less than \$150;
- c. Third or subsequent offenses, in any twelve-month period, a fine of not less than \$200.

SECTION 2: EFFECTIVE DATE: This ordinance shall take effect immediately upon the following publication as required by law.

SECTION 3: REPEALER: All Ordinances or parts of Ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency only.

SECTION 4: SEVERABILITY: If any section, paragraph, subdivision, subsection, clause, or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, subsection, clause, or provision declared invalid and the remainder of this Ordinance shall remain in full force and effect and shall be enforceable.

<u>SECTION 5:</u> <u>CODIFICATION</u>: This Ordinance shall be codified in the Upper Township Code at the sections referred to above.
