AN ORDINANCE REPEALING AND REPLACING CERTAIN SECTIONS OF CHAPTER 140 OF THE CITY CODE OF THE CITY OF VANDALIA, MISSOURI.

WHEREAS, THE CITY OF VANDALIA HAS RECENTLY CHANGED SOME ORGANIZATIONAL STRUCTURES REGARDING THE CITY UTILITY DEPARTMENT AND ALSO THE WATER AND WASTEWATER DEPARTMENT; AND WHEREAS, THIS CHANGE IN STRUCTURES REQUIRES THAT CERTAIN PROVISIONS OF CHAPTER 140 BE CHANGED TO MORE ACCURATELY REFLECT THESE NEW CHANGES.

BE IT HEREBY ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF VANDALIA, MISSOURI AS FOLLOWS:

<u>I.</u> Sections Repealed

Chapter 140 CITY DEPARTMENTS AND COMMITTEES

Section 140.050. Employees-Designated Employees of Public Works Department. The present employees of the Street Department, Park Department and Sanitation Department are hereby designated as employees of the Public Works Department, subject to all rules, regulations and ordinances of the City. Each position presently held by an employee is hereby designated as an authorized position within the Public Works Department.

Section 140.070. Utility Department Established.

There is hereby established within the City a Utility Department which shall consist of the following: Electric Division, Water Division and Sewer Division.

Section 140.080. Responsibility Of Department.

The Utility Department shall be responsible for the operation, maintenance and care of the Electric System, Water System, Sewer System and Weldon (Pete) Steiner Reservoir and Lake and all equipment and appurtenances thereto.

Section 140.090. Superintendent And Employees.

A. The City Administrator shall recommend to the Mayor and Board of Aldermen, some suitable person to serve as Utility Superintendent. The Mayor and Board of Aldermen shall approve or disapprove the person recommended. The Utility Superintendent shall serve at the pleasure of the Mayor and Board of Aldermen.

B. All policies and procedures previously established or approved by the Board of Public Works, which are not in conflict with rules, regulations and ordinances of the City shall remain in full force and effect until such time as they are changed or suspended.

Section 140.110. Responsibility Of Department.

The Water and Wastewater Department shall be responsible for the operation, maintenance and care of the water and wastewater systems and all equipment and appurtenances thereto.

Section 140.120. Superintendent And Employees.

A. The City Administrator shall recommend to the Mayor and Board of Aldermen, some suitable person to serve as Water and Wastewater Superintendent. The Mayor and Board of Aldermen shall approve or disapprove the person recommended. The Water and Wastewater Superintendent shall serve at the pleasure of the Mayor and Board of Aldermen.

B. All policies and procedures previously established or approved by the Board of Public Works, which are not in conflict with rules, regulations and ordinances of the City shall remain in full force and effect until such time as they are changed or suspended.

<u>II.</u> Sections Replaced

Chapter 140 CITY DEPARTMENTS AND COMMITTEES

Section 140.050. Employees-Designated Employees of Public Works Department. The present employees of the Street Department and Park Department are hereby designated as employees of the Public Works Department, subject to all rules, regulations and ordinances of the City. Each position presently held by an employee is hereby designated as an authorized position within the Public Works Department.

Section 140.070. Utility Department Established.

There is hereby established within the City a Utility Department which shall consist of the Electric Division.

Section 140.080. Responsibility Of Department.

The Utility Department shall be responsible for the operation, maintenance and care of the Electric System and all equipment and appurtenances thereto.

Section 140.090. Superintendent And Employees.

A. The City Administrator shall recommend to the Mayor and Board of Aldermen, some suitable person to serve as Utility Superintendent. The Mayor and Board of Aldermen shall approve or disapprove the person recommended. The Utility Superintendent shall serve at the pleasure of the Mayor and Board of Aldermen.

B. All policies and procedures previously established or approved by the former Board of Public Works or the Board of Aldermen, which are not in conflict with rules, regulations and ordinances of the City shall remain in full force and effect until such time as they are changed or suspended.

Section 140.110. Responsibility Of Department.

The Water and Wastewater Department shall be responsible for the operation, maintenance and care of the water and wastewater systems, and Weldon (Pete) Steiner Reservoir and all equipment and appurtenances thereto.

Section 140.120. Superintendent And Employees.

A. The City Administrator shall recommend to the Mayor and Board of Aldermen, some suitable person to serve as Water and Wastewater Superintendent. The Mayor and Board of Aldermen shall approve or disapprove the person recommended. The Water and Wastewater Superintendent shall serve at the pleasure of the Mayor and Board of Aldermen.

B. All policies and procedures previously established or approved by the Board of Public Works, which are not in conflict with rules, regulations and ordinances of the City shall remain in full force and effect until such time as they are changed or suspended.

III. **Ordinances in Conflict**

All ordinances in conflict herewith or to the same effect hereof are hereby repealed.

IV. **Effective date**

This ordinance shall be in full effect from and after the date of passage
