ORDINANCE NO. 2024-021

AN ORDINANCE OF THE CITY OF VENTNOR COUNTY OF ATLANTIC, STATE OF NEW JERSEY AMENDING CHAPTER 114-38 OF THE CITY CODE OF THE CITY OF VENTNOR BY INCREASING TOWING FEES

WHEREAS, Chapter 114 of the Borough Code, Section 114-38, provides the fee schedule for fees to be charged by the Official Towing Companies of the City of Ventnor in accordance with Borough Code, Section 208-10 and Section 208-11; and

WHEREAS, the City wishes to amend its fee Ordinance to increase certain fees and amend other fees; and

WHEREAS, the City desires to amend its Code to reflect this change.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMISSIONERS OF THE CITY COUNCIL OF THE CITY OF VENTNOR, IN THE COUNTY OF ATLANTIC, STATE OF NEW JERSEY, AS FOLLOWS:

SECTION 1. AMENDMENT OF CURRENT CODE.

CHAPTER 114, SECTION 38, entitled "TOWING" shall be amended as follows:

§ 114-38. TOWING.

SECTION 2. REPEALER.

All Ordinances or parts of Ordinances which are in conflict or inconsistent herewith are hereby repealed to the extent of such inconsistency or conflict only.

SECTION 3. SEVERABILITY.

If any section, paragraph, subdivision, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to this section, paragraph, subdivision, clause, or provision declared invalid and the remainder of this Ordinance shall remain in full force and effect and shall be enforceable.

SECTION 4. EFFECTIVE DATE.

This Ordinance shall take effect immediately after final adoption and publication as required by law.
