LOCAL LAW TO AMEND §211-27.16 CANNABIS RETAIL DISPENSARY OVERLAY DISTRICT
BE IT ENACTED, by the Town Board of the Town of Victor, Ontario County, State of New York, as follows:

Section I. Authorization

This local law is adopted pursuant to the authority granted to the Town of Victor at Municipal Home Rule Law Section 10.

Section II. Title and Purpose

This law shall be known as and may be cited as Local Law No. 6-2024. This revision focuses on requiring site plan review and approval by the Planning Board for every Cannabis Retail Dispensary that seeks to establish a location within the overlay district whenever there is a change in ownership, occupant or type of business to ensure the most current NYS licensing, siting and regulatory requirements are being met by the applicants.

Section III. Legislative Finding

The Town Board of the Town of Victor finds and hereby determines the need to make this revision to the Cannabis Retail Dispensary Overlay District.

#### Section IV. Amendment

Chapter §211-27.16 Cannabis Retail Dispensary Overlay District shall be amended as follows:

#### B. General guidelines

(5) Consistent with §211-31. Site Plan Review shall also be required whenever there is a change in the type of business conducted on the premises and/or if there is a change in ownership of such business. The review process shall also be required for any changes of a different occupant for an existing business and/or change of type of business with the same occupant.

#### Section V. <u>Validity and Severability</u>

Should any word, section, clause, paragraph, sentence, part or provision of this local law be declared invalid by a Court of competent jurisdiction, such determination shall not affect the validity of any other part hereof.

### Section VI. Repeal, Amendment and Supersession of Other Laws

All other ordinances or local laws of the Town of Victor which are in conflict with the provisions of this local law are hereby superseded or repealed to the extent necessary to give this local law force and effect during its effective period.

#### Section VII. Effective Date

This Local Law, after its adoption by the Town Board of the Town of Victor, shall take effect immediately upon its filing with the Office of the Secretary of State of the State of New York.
