**ORDINANCE # 2023- 23**

**AN ORDINANCE OF THE TOWNSHIP OF WATERFORD CONFIRMING  
PROVISION OF AMENDING CHAPTER 180 OF THE TOWNSHIP CODE  
CAPTIONED “LITTERING”**

**WHEREAS**, the Waterford Township Environmental Commission has requested the Township’s consideration to increasing the penalty amount to be assessed for a littering violation from One Thousand (\$1,000.00) Dollars; and

**WHEREAS**, the Township previously adopted an Ordinance increasing all Ordinance penalty violations to Two Thousand (\$2,000.00) Dollars.

**NOW THEREFORE, BE IT ORDAINED** by the Mayor and Township Committee of the Township of Waterford, County of Camden, State of New Jersey, as follows:

**SECTION 1.** The Township of Waterford hereby confirms that the penalty provision in the Chapter 180 of the Township Code captioned “Littering” in Section 6 is Two Thousand (\$2,000.00) Dollars.

**SECTION 2.** The minimum monetary penalty shall be set at Two Hundred Fifty (\$250.00) Dollars.

**SECTION 3.** All Ordinances or parts of Ordinances that are inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency only.

**SECTION 4.** If the provisions of any section, subsection, paragraph, subdivision, or clause of this Ordinance shall be judged invalid by a Court of competent jurisdiction, such order of judgment shall not affect or invalidate the remainder of any section, subsection, paragraph, subdivision or clause of this Ordinance.

**SECTION 5.** This Ordinance shall only take effect after final adoption and publication as required by law.
