**ORDINANCE # 2023- 29**

**AN ORDINANCE OF THE TOWNSHIP OF WATERFORD ACCEPTING DONATION  
OF LAND, BLOCK 502, LOT 1 ON THE OFFICIAL TAX MAP  
OF THE TOWNSHIP OF WATERFORD**

**WHEREAS**, BS&D Pliner is the owner of Block 502, Lot 1 on the Official Tax Map of the Township of Waterford; and

**WHEREAS**, said owner has offered to donate the Property to the Township of Waterford at no cost; and

**WHEREAS**, the Mayor and Township Committee for the Township of Waterford have considered this request and determined that said Property can be accepted by donation to the Township.

**NOW THEREFORE, BE IT ORDAINED** by the Mayor and Township Committee of the Township of Waterford, County of Camden, State of New Jersey, as follows:

**SECTION 1.** The statements in the Preamble are incorporated by reference herein.

**SECTION 2.** The Mayor and Township Committee hereby approve and accept the donation of land identified as Block 502, Lot 1 from BS&D Pliner to become part of the Township Land Inventory by Bargain and Sale Deed with Covenants Against Grantor's Acts.

**SECTION 3.** All Ordinances or parts of Ordinances that are inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency only.

**SECTION 4.** If the provisions of any section, subsection, paragraph, subdivision, or clause of this Ordinance shall be judged invalid by a Court of competent jurisdiction, such order of judgment shall not affect or invalidate the remainder of any section, subsection, paragraph, subdivision or clause of this Ordinance.

**SECTION 5.** This Ordinance shall only take effect after final adoption and publication as required by law.
