**ORDINANCE # 2024-15**

**ORDINANCE OF THE TOWNSHIP OF WATERFORD AMENDING CHAPTER  
50 OF THE CODE OF THE TOWNSHIP OF WATERFORD, CAPTIONED  
“POLICE DEPARTMENT”**

**WHEREAS**, the Township periodically reviews various charges imposed by the Township Police Department for off-duty police services; and

**WHEREAS**, as a result of that review, it has been determined that said off-duty charges should be revised as set forth hereinbelow.

**NOW THEREFORE, BE IT ORDAINED** by the Mayor and Township Committee of the Township of Waterford, County of Camden, State of New Jersey as follows:

**SECTION 1.** Chapter 50 of the Code of the Township of Waterford captioned “Police Department,” Section 15-13E(1) shall be amended to read as follows:

1. Contractors hiring Township Police Officers for off-duty employment shall be charged pursuant to the following schedule which includes an hourly rate of pay for the Police Officer, the cost for the use of the police vehicle, plus a fair and reasonable sum representing the administrative costs, overhead and out-of-pocket expenses to the Township of Waterford for providing this service:

- a. Traffic Control: \$95.00 per hour for a full-time Police Officer or Police Class II Reserve Officer on any traffic control sites requiring work zone safety certifications.
- b. Other Traffic Control: \$95.00 per hour for a full-time Police Officer or Police Class II Reserve Officer.
- c. Other Police Services: \$95.00 per hour for a full-time Police Officer or Police Class II Reserve Officer.
- d. Police Vehicle Fee: \$20.00 per hour.
- e. Administrative Fee: \$10.00 per hour.

- f. When 4 or more officers are requested, the vehicle fee and the Administrative Fee will be reduced by 50%.
- g. There is a 4-hour minimum per officer for all Off Duty Employment that is scheduled, unless it is cancelled at least 2 hours prior to the start time of the event. If there is a delayed start there will still be a 4-hour minimum imposed.

**SECTION 2.** All Ordinances or parts of Ordinances inconsistent with this Ordinance, are hereby repealed to the extent of such inconsistency only.

**SECTION 3.** If the provisions of any section, subsection, paragraph, subdivision, or clause of this Ordinance shall be judged invalid by a Court of competent jurisdiction, such order of judgment shall not affect or invalidate the remainder of any section, subsection, paragraph, subdivision, or clause of this Ordinance.

**SECTION 4.** This Ordinance shall take effect after final adoption and publication as required by law.
