## TOWNSHIP OF WASHINGTON BERKS COUNTY, PENNSYLVANIA

## ORDINANCE NO 2023-2

AN ORDINANCE OF THE TOWNSHIP OF WASHINGTON, BERKS COUNTY, PENNSYLVANIA, SUPPLEMENTING SECTION 125-2.1 ENTITLED "MAXIMUM SPEED LIMITS ESTABLISHED ON CERTAIN ROADS", OF ARTICLE IA, ENTITLED "MAXIMUM SPEED LIMITS", AND SECTION 125-22 "STOP INTERSECTIONS ESTABLISHED; ENTITLED VIOLATIONS AND PENALTIES", OF ARTICLE VI ENTITLED "STOP AND YIELD INTERSECTIONS", OF CHAPTER 125, ENTITLED "VEHICLES AND TRAFFIC", OF THE CODE OF ORDINANCES OF THE TOWNSHIP OF WASHINGTON BY ESTABLISHING A MAXIMUM SPEED LIMIT OF 25 MILES PER HOUR ON APPLE STREET, AUDREY LANE, AVALON CIRCLE, BACK COUNTRY ROAD, CHASE CIRCLE, CHRISTI DRIVE, COMPTON WAY, DOCWILL DRIVE, GEHRINGER ROAD, DRIVE, JOY CIRCLE, NATALIE O'DONOGHUE WAY, TIFFANY CIRCLE, AND WESTFIELD DRIVE AND ESTABLISHING STOP INTERSECTIONS AT AVALON CIRCLE HEADING EAST AT COUNTRY LINE ROAD, CHASE CIRCLE HEADING NORTH AT CHRISTI DRIVE, CHRISTI DRIVE HEADING SOUTHWEST AT GEHRINGER ROAD, CHRISTI DRIVE HEADING NORTHWEST AT DOCWILL DRIVE, COMPTON WAY HEADING NORTH AT AVALON CIRCLE, DOCWILL DRIVE HEADING SOUTHWEST AT GEHRINGER ROAD, JOY CIRCLE HEADING NORTHEAST AT GEHRINGER ROAD (BOTH LOCATIONS), NATALIE CIRCLE HEADING NORTHWEST AT COUNTY LINE ROAD, O'DONOGHUE WAY HEADING SOUTHWEST AT CHRISTI DRIVE, AND TIFFANY CIRCLE HEADING EAST AT JOY CIRCLE.

**BE IT ENACTED** by the Board of Supervisors of the Township of Washington, Berks County, Pennsylvania, and **IT IS HEREBY ENACTED AND ORDAINED** by the authority of the same as follows:

SECTION 1. Section 125-2.1, entitled "Maximum Speed Limits Established on Certain Roads", of Article IA, entitled "Maximum Speed Limits", of Chapter 125, entitled "Vehicles and Traffic", of the Code of Ordinances of the Township of Washington, Berks County, Pennsylvania, is hereby supplemented by adding thereto speed limits for the following roads:

SECTION 2. Section 125-22 entitled "Stop Intersections Established; Violations and Penalties", of Article VI entitled "Stop and Yield Intersections", of Chapter 125, entitled "Vehicles and Traffic", of the Code of Ordinances of the Township of Washington, Berks County, Pennsylvania, is hereby supplemented by adding thereto the following stop intersections:

**SECTION 3.** If any sentence, clause, section, or part of this Ordinance is, for any reason, found to be unconstitutional, illegal, or invalid, such unconstitutionality, illegality or invalidity shall not affect or impact any other remaining provisions, sentences, clauses, sections or parts of this Ordinance. It is hereby declared as the intent of the Township that this Ordinance would have been adopted had such unconstitutional, illegal, or invalid sentence, clause, section or part thereof had not been included herein.

**SECTION 4.** All ordinances or parts of ordinances conflicting with the provisions of this Ordinance are hereby repealed insofar as they are inconsistent with this Ordinance.

SECTION 5. This Ordinance shall become effectively immediately upon enactment.

**SECTION 6.** The Code of Ordinance of the Township of Washington, Berks County, Pennsylvania, as amended, shall be and remain unchanged and in full force and effect except as amended, supplemented, and modified by this Ordinance. This Ordinance shall become a part of the Code of Ordinances of the Township of Washington, Berks County, Pennsylvania, as amended, upon adoption.
