Section 1. Section 140-10A(1), entitled "Sewer Use Rents," of Chapter 140, entitled "Sewers," of the Code of the Village of Washingtonville is hereby amended by establishing a new sewer use rate as follows:

One hundred forty percent (140%) of the water billing each quarter.

<u>Section 2</u>. This new rate shall apply to all sewer use commencing with the quarter beginning August 1, 2004.

Section 3. This local law shall take effect immediately.
