VILLAGE OF WASHINGTONVILLE

LOCAL LAW NO. 3 OF 2017

A LOCAL LAW AMENDING CHAPTER 45 OF THE VILLAGE OF WASHINGTONVILLE CODE ENTITLED "ALCOHOLIC BEVERAGES"

Be it enacted by the Board of Trustees of the Village of Washingtonville, County of Orange, State of New York, as follows:

Section 1. Purpose.

This Local Law is enacted for the purpose of amending existing regulations to prohibit possession of open containers of alcoholic beverages and/or consumption of alcoholic beverages on publicly owned or controlled property within the Village of Washingtonville.

Section 2. Amendment.

The portion of the Village of Washingtonville Code entitled Chapter 45. ALCOHOLIC BEVERAGES shall be and hereby is amended by this Local Law as follows:

Section § 45-2. Consumption in certain public places and private areas, is amended by adding the bold underlined portion as follows:

A. Prohibited. No person shall within the Village of Washingtonville drink or otherwise consume liquor, wine, beer or other alcoholic beverages while such person is in or upon any Village owned or controlled property, including, but not limited to, any public sidewalk, street, highway, parking lot, bathing beach, public park, lot or building or such other public place as defined by § 240.00 of the Penal Law of the State of New York or on private property without invitation or permission of the owner or occupant of such property.

B. Possession of open containers. No person shall carry or have in his or her possession within the Village of Washingtonville any open bottle or open container containing liquor, wine, beer or other alcoholic beverage with the intent of the possessor or another to consume the same in any of the <u>Village owned or controlled property and/or all</u> public places and locations described in Subsection A of this section.

Section 3. Severability

If any part or provision of this Local Law or the application thereof to any person or circumstance be adjudged invalid by any court of competent jurisdiction, such judgment shall be confined in its operation to the part or provision or application directly involved in the controversy in which such judgment shall have been rendered and shall not affect or impair the validity of the remainder of this Local Law or the application thereof to other persons or circumstances, and the Board of Trustees of the Village of Washingtonville hereby declares that it would have passed this Local Law or the remainder thereof had such invalid application or

invalid provision been apparent.

Section 4. Repeal

All ordinances, local laws and parts thereof inconsistent with this Local Law are hereby repealed.

Section 5. Authority

This Local Law is enacted pursuant to the Municipal Home Rule Law. This Local Law shall supersede the provisions of Village Law to the extent that it is inconsistent with the same, and to the extent permitted by the New York State Constitution, the Municipal Home Rule Law, or any other applicable statute.

Section 6. Effective Date

This law shall become effective upon filing with the office of the New York State Secretary of State in accordance with section 27 of the Municipal Home Rule Law.
