

ORDINANCE NO. 2024-02

AN ORDINANCE OF THE WARWICK TOWNSHIP BOARD OF SUPERVISORS AMENDING CHAPTER 177 OF THE WARWICK TOWNSHIP CODE TO ADD STOP INTERSECTIONS AND RESTRICT PARKING IN DESIGNATED BICYCLE LANES; AND REPEALING CHAPTER 77 OF THE WARWICK TOWNSHIP CODE TO REMOVE REDUNDANT EROSION CONTROL REGULATIONS

Background

1. The Warwick Township Board of Supervisors desires to ensure the public health, safety, and welfare of the residents of Warwick Township.
2. The Board of Supervisors has determined that it is in the best interest of the health, safety and welfare of the community to adopt an ordinance amending Chapter 177 of the Warwick Township Code to add stop intersections and to restrict parking in designated bicycle lanes.
3. The Board of Supervisors has determined that in order to improve the clarity of the Township stormwater regulations it is appropriate to adopt an ordinance repealing Chapter 77 of the Warwick Township Code to remove redundant erosion control regulations already found in Chapter 157 Stormwater Management and Chapter 163 Subdivision and Land Development.

Section One

The Warwick Township Code of Ordinances, Chapter 177, Article II, §20.A is hereby amended as follows. All other stop intersections listed in the Township Code shall remain in full force and effect.

Add Stop Signs:

Fairway Drive at Sand Trap Road

Marquis Lane at Quartermaster Lane (three-way stop)

Quartermaster Lane at Marquis Lane (four-way stop)

Jamison Place Clubhouse parking lot at Quartermaster Lane

Marquis Lane at Meetinghouse Road Quartermaster Lane at York Road

Section Two

The Warwick Township Code of Ordinances, Chapter 177, Article IV, §26 is hereby amended to remove the parking restrictions. All other parking regulations currently listed in Chapter 177, Article IV §26 shall remain in full force and effect.

Section Three

The Warwick Township Code of Ordinances, Chapter 177, Article IV, §26 is hereby amended to add the parking restrictions. All other parking regulations currently listed in Chapter 177, Article IV §26 shall remain in full force and effect.

Section Four

Chapter 77 of Part II of the Warwick Township Code of Ordinances, Erosion Control is hereby repealed in its entirety.

Section Five

Repealer. All ordinance or parts of ordinances which are inconsistent herewith are hereby repealed.

Section Six



Effective Date. This Ordinance shall be effective five (5) days after enactment.




