ORDINANCE NO. 2021-018**

AN ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER 107 OF THE CODE OF THE BOROUGH OF WALLINGTON SO AS TO AMEND THE RATES OF COMPENSATION PAID FOR THE SERVICES OF OFF-DUTY LAW ENFORCEMENT OFFICERS AS PROVIDED IN SECTION 107-15 OF THE CODE

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE BOROUGH OF WALLINGTON AS FOLLOWS:

1. Subsection A. of Section 107-15 of the Code of the Borough of Wallington is amended and supplemented to read as follows:

A. The following rate schedule shall apply to any individual and/or business entity as described:

- (1) Except as otherwise provided, all individuals and/or business entities shall pay a charge of \$100 per hour. Of that amount, a fee of \$10 per hour shall be retained by the Borough of Wallington to cover administrative costs, overhead and out-of-pocket expenses.
- (2) There will be a four-hour minimum charge. If a request for employment is cancelled less than 7 hours prior to the start of the job the individual or entity will be charged for four-hours.
- (3) With respect to the Wallington Board of Education, the rate of compensation shall be \$50 per hour.
- (4) If a police car or other vehicle owned by, or in the service of, the Borough of Wallington is used, the Borough shall receive an additional \$60 per hour.

2. Except as amended and supplemented by this Ordinance, Chapter 107 of the Code shall remain in full force and effect.

3. All ordinances or other provisions of the Code inconsistent with the provisions of this Ordinance is hereby repealed to the extent of such inconsistency.

4. This ordinance shall take effect upon final passage and according to law.
