NOW, THEREFORE, BE IT RESOLVED, by the Borough Council of the Borough of Wallington, in the County of Bergen, as follows:

SECTION 1. Schedule E1 of Section 9-6A of the Revised Ordinance of the Borough of Wallington, is hereby amended by renewing or granting the Handicapped Parking Restricted Parking Spaces for the above-named individuals.

SECTION 2. The handicapped parking spaces herein designated shall be valid from this date. The Mayor and Council shall have the authority to adopt an Ordinance listing all approved handicapped parking spaces at the annual reorganization meeting of the Borough Council in January of each year. Additionally, the Mayor /Council of the Borough of Wallington shall have to power to Add or Delete from the above list throughout the calendar year subject to recommendation by the Board of Health/Handicapped Parking Committee and through formal Resolution by the Mayor/Council at any time up to December 31, of the calendar year.

SECTION 3. If any section, part of any section, or clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid, such decision shall not affect the remaining provisions of this Ordinances. The Governing Body of the Borough of Wallington declares that it would have passed of the Ordinances and each Section Sub-Section thereof, irrespective of the fact that any one or more of the Sections, Sub-Section, Sentences, Clauses or Phrases may be declared unconstitutional or invalid.

SECTION 4. This ordinance shall take effect immediately upon passage and publication according to law.

SECTION 5. All Ordinances or parts of Ordinances inconsistent herewith are hereby repealed as to such inconsistencies.
