

**BOROUGH OF WALLINGTON
BERGEN COUNTY
ORDINANCE NO. 2022-016**

CAPITAL ORDINANCE TO AUTHORIZE THE MAKING OF VARIOUS PUBLIC IMPROVEMENTS IN, BY AND FOR THE BOROUGH OF WALLINGTON, IN THE COUNTY OF BERGEN, STATE OF NEW JERSEY AND TO APPROPRIATE THE SUM OF \$1,275,000 FROM VARIOUS GRANTS, AND FROM THE CAPITAL IMPROVEMENT FUND AND CAPITAL FUND BALANCE OF THE BOROUGH, TO PAY THE COST THEREOF.

BE IT ORDAINED by the Borough Council of the Borough of Wallington, in the County of Bergen, State of New Jersey, as follows:

Section 1. The Borough of Wallington, in the County of Bergen, State of New Jersey (the "Borough") is hereby authorized to make various public improvements in, by and for said Borough, as more particularly described in Section 4 hereof. The cost of the improvements includes all work, materials and appurtenances necessary and suitable therefor.

Section 2. There is hereby appropriated to the payment of the cost of making the improvements described in Sections 1 and 4 hereof (hereinafter referred to as "purposes"), the respective amounts of money hereinafter stated as the appropriation for said respective purposes. Said appropriation shall be met from the various grants, and amounts in the Capital Improvement Fund and Capital Fund Balance of the Borough, appropriated by this ordinance. Said improvements shall be made as general improvements

and no part of the cost thereof shall be assessed against property specially benefited.

Section 3. It is hereby determined and stated that the making of such improvements is not a current expense of said Borough.

Section 4. The several purposes hereby authorized are set forth in the following "Schedule of Improvements, Purposes and Amounts" which schedule also shows (1) the amount of the appropriation and the estimated cost of each such purpose, and (2) the amount of each sum which is to be provided by the various grants hereinafter appropriated, and (3) the amount of each sum which is to be provided by the appropriation from the Capital Improvement Fund hereinafter made, and (4) the amount of each sum which is to be provided by the appropriation from Capital Fund Balance hereinafter made, and (5) the period of usefulness of each such purpose, according to its reasonable life:

A. Undertaking of roadway and drainage improvements of Parkview.

C. Undertaking of streetscape improvements at Union Boulevard and Locust Avenue (Phase 1).

Section 5. The sum of \$146,025 received or to be received as a grant from the Bergen County Community Development Program, pursuant to the Federal Housing and Community Development Act, is hereby appropriated to the payment of the cost of the improvements to Parkview authorized in Section 4.A above.

Section 6. The sum of \$236,000 received or to be received as a grant from the State of New Jersey Department of Transportation is hereby appropriated to the payment of the cost of the streetscape improvements authorized in Section 4.C above.

Section 7. The sum of \$63,750 is hereby appropriated from the Capital Improvement Fund of the Borough to the payment of the cost of said purposes.

Section 8. The sum of \$829,225 is hereby appropriated from Capital Fund Balance of the Borough to the payment of the cost of said purposes.

Section 9. The capital budget is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency therewith and the resolutions promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director, Division of Local Government Services, is on file with the Borough Clerk and is available for public inspection.

Section 10. This ordinance shall take effect at the time and in the manner provided by law.
