#### **ORDINANCE NO. 2024-010**

# AN ORDINANCE TO ESTABLISH AND OR RENEW HANDICAPPED PARKING RESTRICTED PARKING SPACES AT LOCATIONS WITHIN THE BOROUGH.

**WHEREAS**, NJSA 39: 4-197.5 and 6 authorize the Mayor and Council to establish areas in front of residences where parking is restricted to persons holding a handicapped or disabled identification card issued by the Motor Vehicle Commission (each called a "Handicapped Parking Restricted Parking Area"); and

**WHEREAS**, the Borough has from time to time established those areas permitting parking only by such persons; and

**WHEREAS**, the Borough desires to amend and restate the locations within the Borough where such a Handicap Parking Restricted Parking Area has been established.

**NOW THEREFORE BE IT ORDAINED** by the Mayor and Council of the Borough of Wallington as follows:

Schedule XXIII of Section 307-55 of the Code of the Borough of Wallington is amended and supplemented by renewing or establishing the Handicap Parking Restricted Parking Areas to the individuals and in front of the locations named below:
