ORDINANCE NO. 2024-014

**AN ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER 107 OF THE CODE OF
THE BOROUGH OF WALLINGTON TO AMEND THE DESIGNATION OF THE
“APPROPRIATE AUTHORITY” FOR THE WALLINGTON POLICE DEPARTMENT**

BE IT ORDAINED by the Mayor and Council of the Borough of Wallington as follows:

1. Subsections C, D, E & F of Section 107-1 of the code of the Borough of Wallington are amended and supplemented to read as follows:

C. Both the Mayor and Council and the Borough of Wallington shall be considered to be the Appropriate Authority, as provided in the New Jersey statutes. The Mayor and Council may, by resolution, delegate all or some part of the role of the “Appropriate Authority” to the Borough Administrator.

D. The Appropriate Authority shall be responsible for the overall performance of the Police Department and shall adopt and promulgate rules and regulations for the governance of the Police Department and for the discipline of its members, which rules and regulations shall be first ratified by the Mayor and Council.

E. The Chief of Police shall be directly responsible to the Appropriate Authority for the efficiency and day-to-day operation of the Police Department.

F. Pursuant to policies established by the Appropriate Authority, or at its direction, the Chief of Police shall:

(1) Administer and enforce the rules and regulations of the Police Department and any special emergency directive for the disposition and discipline of the Department and its members and officers.

(2) Have, exercise and discharge the functions, powers and duties of the Police Department.

(3) Prescribe the duties and assignments of all members and officers.

(4) Delegate such authority as may be deemed necessary for the efficient operation of the Police Department.

(5) Report at least monthly to the Appropriate Authority, or its designee, in such form as shall be prescribed on the operation of the Police Department during the preceding month and shall such other reports as may be requested by the Appropriate Authority.

2. All ordinances or parts which are inconsistent with the provisions of this ordinance are hereby repealed, but only to the extent of such inconsistency.

3. This ordinance shall take effect after publication thereof and final passage as required by law.


