**ORDINANCE NO. # 2025-015**

**AN ORDINANCE TO AMEND CHAPTER 160 OF THE CODE OF THE  
BOROUGH OF WALLINGTON ENTITLED "AMUSEMENT DEVICES."**

**WHEREAS**, Chapter 160 of the Code of the Borough of Wallington controls and regulates amusement devices within the Borough; and

**WHEREAS**, Section 160-7 of the Borough Code entitled "Definitions" sets forth and defines the terms used in this chapter: and

**WHEREAS**, the Mayor and Council of the Borough of Wallington have determined that it is in the best interest of the Borough to amend the above-referenced code section and remove the exclusion for jukeboxes.

**NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND  
COUNCIL OF THE BOROUGH OF WALLINGTON, COUNTY OF BERGEN,  
AND STATE OF NEW JERSEY, AS FOLLOWS:**

**SECTION ONE:**

Section 160-7 of the Code of the Borough of Wallington is amended to delete the first paragraph defining the term for Coin-Operated Amusement or Entertainment Device and replaced it with the following:

**COIN-OPERATED AMUSEMENT OR ENTERTAINMENT DEVICE**

Any automatic, mechanical or electronic amusement device, game or device of skill or entertainment, such as pinball machines, electronic games, bowling machines, mechanical game machines, ski ball machines, bowling machines, pokereno machines and commercial pool tables, which is or are operated or set in motion by the deposit therein of any coin or coins, tokens or slugs, or the like thereof, or paper money, purchased for cash and including electronic video games or machines or similar devices.

**SECTION TWO: Repealer:**

All Ordinances or parts of Ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency only.

**SECTION THREE: Severability:**

If any section, subsection, paragraph, sentence or other part of this Ordinance is adjudged unconstitutional or invalid, such judgment shall not affect, impair or invalidate the remainder of this Ordinance, but shall be confined in its effects to the section, subsection, paragraph, sentence or other part of this Ordinance directly involved in the controversy in which said judgment shall have been rendered and all other provisions of this Ordinance shall remain in full force and effect.

**SECTION FOUR: Effective Date:**

This Ordinance shall take effect immediately upon final adoption and publication and in the manner provided by law.
