ORDINANCE NO. 11-2026

AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF WALL, IN THE COUNTY OF MONMOUTH, STATE OF NEW JERSEY TO AMEND WALL TOWNSHIP CODE CHAPTER 215-48 SCHEDULE XVI: SPEED LIMITS TO LIMIT VEHICLE SPEED ALONG A PORTION OF SEA GIRT AVENUE TO 25 MILES PER HOUR

WHEREAS, the Township of Wall, through adoption of Wall Municipal Code Chapter 215-1 recognizes that Title 39, of the New Jersey Statues, applies to certain roadways within the Township of Wall; and, that Wall Township has the prerogative to establish speed limits upon certain municipal roadways; and,

WHEREAS, the Township of Wall, through adoption of Wall Municipal Code Chapter 215-19 recognizes that Wall Township has the prerogative to establish speed limits that shall apply in both directions and that such speed limits shall be memorialized in Wall Township Municipal Code Chapter 215-48; and,

WHEREAS, the Township Engineer in conjunction with the Township’s Consulting Engineer, French and Parrello, has determined that it is in the best interests of the residents of Wall Township and neighboring Municipalities to establish a speed limit along Sea Girt Avenue from Dogwood Lane to 8<sup>th</sup> Avenue of 25 miles per hour; and

WHEREAS, all additions are shown in ***bold italics with underlines***. The deletions are shown as ~~***strikeovers in bold italics***~~. Sections of Chapter 215-48 that will remain unchanged are shown in normal type.

NOW, BE IT ORDAINED by the Township Committee of the Township of Wall, in the County of Monmouth, in the State of New Jersey, as follows:

Chapter 215-48 Schedule XVI: Speed Limit

Sea Girt Avenue	35 miles per hour	<del><i>Along entire length</i></del> <del><i>Dogwood Lane to Baileys</i></del> <del><i>Corner Road</i></del>
<u>Sea Girt Avenue</u>	<u>25 miles per hour</u>	<u>Dogwood Lane to 8<sup>th</sup></u> <u>Avenue</u>



If any word, phrase, clause, section or provision of this Ordinance shall be found by any Court of competent jurisdiction to be unenforceable, illegal or unconstitutional such word, phrase, clause, section or provision shall be severable from the balance of the Ordinance and the remainder of the Ordinance shall remain in full force and effect.

This Ordinance shall take effect upon publication thereof after final passage according to law and approval by the State of New Jersey.
